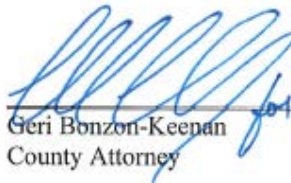

RESOLUTION NO. R-1171-25

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO PROVIDE A MONTHLY REPORT TO THE BOARD LISTING ALL COUNTY JOB POSITIONS UNDER THE COUNTY MAYOR'S PURVIEW THAT ARE CURRENTLY OPEN, VACANT, AND FUNDED, INCLUDING THE COUNTY DEPARTMENT, DIVISION, AND FUNDING SOURCE(S) FOR EACH POSITION, AND THE LENGTH OF TIME EACH POSITION HAS BEEN OPEN AND VACANT

WHEREAS, this Board wishes to monitor the number of open, vacant, and funded County job positions under the County Mayor's purview to allow for more informed fiscal planning and ensure that the financial implications of any such positions are given appropriate consideration by this Board,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Mayor or County Mayor's designee to provide a monthly report to this Board starting on or before January 1, 2026, and continuing each month thereafter until further directed by this Board, listing all County job positions under the County Mayor's purview that are currently open, vacant, and funded, including the County department, division, and funding source(s) for each position, and the length of time each position has been open and vacant. Each monthly report shall be organized or sorted by County department, and include the beginning and end dates of each funding source and a description of any specific purpose for which the funds must be used (*e.g.*, any applicable grant, federal, state, or local requirements). Furthermore, each monthly report shall provide a summary detailing any changes or differences between the current and previous monthly

reports and the rationale or explanation for such changes or differences. The County Mayor or County Mayor's designee shall place each completed monthly report on an agenda of the full Board without committee review pursuant to rule 5.06(j) of the Board's Rules of Procedure.

The Prime Sponsor of the foregoing resolution is Senator René García. It was offered by Commissioner **Danielle Cohen Higgins**, who moved its adoption. The motion was seconded by Commissioner **Kionne L. McGhee** and upon being put to a vote, the vote was as follows:
