RESOLUTION NO. R-1095-25

RESOLUTION URGING THE FLORIDA LEGISLATURE TO
APPROPRIATE FUNDING FOR A WORKFORCE SOLUTION
PROJECT LED BY THE MIAMI-DADE BEACON COUNCIL

WHEREAS, promoting local job opportunities for Miami-Dade County residents is an important goal of this Board; and

WHEREAS, the Miami-Dade Beacon Council is a non-profit organization whose mission is to drive a more sustainable, inclusive and competitive economy for Greater Miami by, among other things, bridging industry needs with talent development; and

WHEREAS, the Miami-Dade Beacon Council seeks funding to support a project it is leading, presently titled “TalentBridge: Empowering Florida’s Workforce, Strengthening Florida’s Economy” (the “Project”); and

WHEREAS, the Project would create a centralized platform offering real-time labor market data showing trends and hiring needs, and map training programs, credentials, and funding options; and

WHEREAS, the Project would also provide targeted job training, internship opportunities, and feature workforce readiness programs, including programs to integrate disabled workers into the employment ecosystem; and

WHEREAS, the Project is accordingly anticipated to, among other benefits, increase employment in high-demand sectors and drive additional employment opportunities through improved workforce satisfaction scores; and

WHEREAS, Senator Ana Maria Rodriguez (R – Doral) previously submitted Local Funding Initiative Request No. 1161 for fiscal year 2025-2026, which requested \$2,500,000.00 for the Project; and

WHEREAS, Representative Demi Busatta (R – Coral Gables) previously submitted Appropriations Project Request No. 3577 for fiscal year 2025-2026, which requested \$2,500,000.00 for the Project; and

WHEREAS, it is anticipated that similar appropriations project requests will be submitted for fiscal year 2026-2027; and

WHEREAS, this board wishes to urge the Florida Legislature to provide funding for the “TalentBridge: Empowering Florida’s Workforce, Strengthening Florida’s Economy” project,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges the Florida Legislature to appropriate funding for a workforce solution project led by the Miami-Dade Beacon Council, presently titled “TalentBridge: Empowering Florida’s Workforce, Strengthening Florida’s Economy.”

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Governor, the Senate President, the House Speaker, Senator Ana Maria Rodriguez, Representative Demi Busatta, and the remaining Members of the Miami-Dade State Legislative Delegation.

Section 3. Directs the County’s state lobbyists to advocate for the legislation described in section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2026 State Legislative Package to include this item.

The Prime Sponsor of the foregoing resolution is Commissioner Natalie Milian Orbis. It was offered by Commissioner **Roberto J. Gonzalez**, who moved its adoption. The motion was seconded by Commissioner **Natalie Milian Orbis** and upon being put to a vote, the vote was as follows:
