RESOLUTION APPROVING ALLOCATIONS FROM THE FY 2025-26 DISTRICT 2 CBO DISCRETIONARY RESERVE, FROM THE FY 2025-26 DISTRICT 2 DESIGNATED PROJECT PROGRAM, AND FROM THE FY 2025-26 DISTRICT 2 ARENA NAMING RIGHTS FUND; RESCINDING AN ALLOCATION FROM THE FY 2024-25 DISTRICT 2 DESIGNATED PROJECT PROGRAM; AND WAIVING THE REQUIREMENTS OF RESOLUTION NO. R-238-21 AS RELATED TO THE ALLOCATIONS FROM THE ARENA NAMING RIGHTS FUND

WHEREAS, this Board desires to allocate funds from the FY 2025-26 District 2 CBO Discretionary Reserve, from the FY 2025-26 District 2 Designated Project Program, and from the FY 2025-26 District 2 Arena Naming Rights Fund and rescind an allocation from the FY 2024-25 District 2 Designated Project Program in accordance with the attached memorandums; and
