**RESOLUTION MAKING APPOINTMENT TO FILL THE
VACANCY IN THE OFFICE OF COUNTY COMMISSIONER
FOR DISTRICT 5**

WHEREAS, Commissioner Eileen Higgins irrevocably resigned as Miami-Dade County Commissioner for District 5, effective November 5, 2025; and

WHEREAS, the Office of County Commissioner for District 5 became vacant on November 5, 2025; and

WHEREAS, section 1.07 of the Home Rule Charter requires that vacancies in the office of County Commissioner “shall be filled by majority vote of the remaining members of the Board within 30 days, or the Board shall call an election to be held not more than 90 days thereafter to fill the vacancy”; and

WHEREAS, section 1.07 of the Home Rule Charter further provides that a “person appointed shall serve only until the next county-wide election”; and

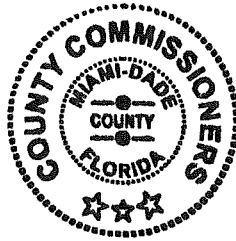
WHEREAS, the Board desires to fill the vacancy in Miami-Dade County Commissioner, District 5 by appointment until the next county-wide election,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that Vicki L. Lopez is hereby appointed to serve as Miami-Dade County Commissioner, District 5 until the next county-wide election.
