TO SUBMIT FINAL REPORT**

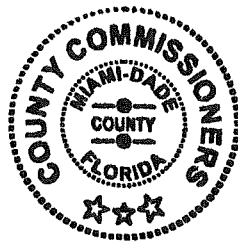
WHEREAS, at the December 16, 2025 Board of County Commissioners meeting, a motion was made to amend Resolution No. R-225-24 to extend the deadline for the Charter Review Task Force to submit its final report to no later than 14 days prior to the Board's second regularly scheduled meeting in May 2026 rather than its first regularly scheduled meeting in April 2026,
