RESOLUTION NO. R-1226-25

RESOLUTION ESTABLISHING COUNTY POLICY THAT THE FINAL ADOPTED BUDGET BE MADE AVAILABLE TO EACH COUNTY COMMISSIONER AND THE PUBLIC NO LATER THAN 60 DAYS AFTER THE COUNTY BUDGET'S ADOPTION; DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO PROVIDE A REPORT IF SUCH REQUIREMENT IS NOT MET; DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO MAKE AVAILABLE A PRINTED COPY OF THE ADOPTED BUDGET FOR EACH COUNTY COMMISSIONER WITHIN 90 DAYS OF THE COUNTY BUDGET'S ADOPTION

WHEREAS, chapter 129, Florida Statutes, provides that the County budget shall be prepared, summarized and approved by the Board and that it shall be balanced; and

WHEREAS, section 5.03(B) of the Miami-Dade County Home Rule Charter provides that, between June 1 and July 15, the Mayor shall prepare a proposed budget for Miami-Dade County, Florida, for the subsequent fiscal year, and the County Mayor or County Mayor's designee posts such proposed budget, which is a three-volume document ("proposed budget book"), on the County's website; and

WHEREAS, section 5.03(B) further provides that the Board shall hold hearings and adopt a budget on or before the dates required by law; and

WHEREAS, accordingly, each September, the County adopts its budget for the following fiscal year; and

WHEREAS, soon after the County adopts its annual budget, County staff completes and posts the final adopted budget book, which is a three-volume document ("adopted budget book"),

on the County's website, which incorporates the changes that occur between the publishing of the proposed budget book and the adoption of the budget at the County's final budget hearing; and

WHEREAS, pursuant to Section 129.03(3)(c), Florida Statutes, and Section 218.35(4), Florida Statutes, within 30 days after the adoption of the County's budget ordinance(s), the County's adopted budget and the final approved budget of the clerk of the circuit court must be posted on the County's official website and must remain on the website for at least 2 years; and

WHEREAS, the Board desires to receive the County's adopted budget book as soon as possible; and

WHEREAS, accordingly, the Board directs County Mayor or County Mayor's designee to make available a printed copy of the adopted budget for each County Commissioner within 90 days of its adoption,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

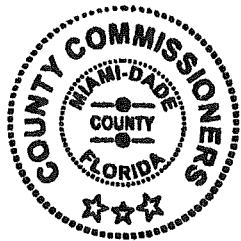
Section 1. The foregoing recitals are incorporated in this resolution and are approved.

Section 2. This Board establishes as County policy that the final adopted budget shall be made available to each County Commissioner and the public no later than 60 days after the County budget's adoption. This Board further directs the County Mayor or County Mayor's designee to provide a written report no later than 60 days after the County budget's adoption if unable to meet this requirement. Pursuant to rule 5.06(j) of the Board's Rules of Procedure, the completed report shall be placed on an agenda of the full Board without committee review. Furthermore, this Board directs the County Mayor or County Mayor's designee to make available a printed copy of the adopted budget for each County Commissioner within 90 days of the County budget's adoption.

The Prime Sponsor of the foregoing resolution is Senator René García. It was offered by Commissioner **Vicki L. Lopez**, who moved its adoption. The motion was seconded by Commissioner **Danielle Cohen Higgins** and upon being put to a vote, the vote was as follows:
