Subject: Resolution Approving and Authorizing Miami-Dade County, through Miami-Dade Fire Rescue Department, to apply for, receive and expend up to \$250,000 in grant funds from the Florida Inland Navigation District Waterways Assistance Program

Summary

This item seeks approval and authorization to apply for, receive, and expend up to \$250,000.00 in grant funding awarded by the Florida Inland Navigation District (FIND) through its Waterways Assistance Program (WAP) to Miami-Dade County, through the Miami-Dade Fire Rescue Department (MDFR), for upgrades to the fireboat lift system at the Port of Miami. Under section 374.976, Florida Statutes, and chapter 66B-2, Florida Administrative Code, the WAP supports local governmental agencies in enhancing public access to the Atlantic Intracoastal Waterway and related waterways. FIND allocates approximately \$10–12 million annually, funding public navigation projects and other waterway-related initiatives. Recipient agencies are required to provide matching funds of between 50% to 75% of the total project cost.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the attached resolution authorizing the County Mayor's or County Mayor designee's application, receipt and expenditure of up to \$250,000.00 in WAP grant funds. It is further recommended that the County Mayor or County Mayor's designee be further authorized to utilize up to \$250,000.00 in Fire District Funds to satisfy any cash match funding requirements. Additionally, it is recommended that the County Mayor or County Mayor's designee be authorized to execute all necessary agreements, documents, and amendments, provided that any such amendments do not alter the purpose of the agreement from the WAP.

Scope

The services provided with these grant funds will be countywide.

Delegation of Authority

In addition to authorizing the County Mayor's or County Mayor designee's application, receipt and expenditure of up to \$250,000.00 in grant funds from the WAP and, subject to available funding, utilization of up to \$250,000.00 in Fire District Funds to satisfy any cash match funding requirements, this item also authorizes the County Mayor or County Mayor's designee to execute all necessary agreements, documents, and amendments as well as to exercise the provisions contained in the award, provided that any amendments are for the purposes described herein and have been approved by the County Attorney's Office for form and legal sufficiency.

Fiscal Impact/Funding Source

The WAP is funded and administered by the FIND, a state independent special taxing district, established for the continued management and maintenance of the Atlantic Intracoastal Waterway. Awarded agencies must provide a cash match between 50% to 75% of the total project cost, depending on the category that the project is submitted under. Matching funds will come from the Fire District fund.

Track Record/Monitor

The grant award will be monitored by the MDRF Grants Management Bureau.

Background

Authorized under section 374.976, Florida Statutes, and governed by chapter 66B-2, Florida Administrative Code, the FIND WAP was created by the Florida Legislature to assist local agencies in enhancing waterway access points. Over the past 39 years, FIND has distributed more than \$162 million to support navigation, access facilities, environmental education, boating safety, beach renourishment, and other waterway-related improvements. Eligible projects include dredging, aids and markers, inlet management, ramp and dock improvements, shoreline stabilization, environmental and recreational facilities, and boating safety programs

Miami-Dade Fire Rescue (MDFR) is a core partner to local, state, and federal maritime agencies, maintaining 24/7 readiness to protect the County's waterways that support major commercial, industrial, and recreational activity. MDRF's Marine Operations Bureau is solely responsible for fire protection and all hazard emergency response across more than 600 square nautical miles of heavily trafficked inland and coastal waters in eastern South Florida. MDRF's existing fireboats lift at PortMiami. The existing docks are 17 years old, structurally outdated, and are unable to support the operational requirements of the much larger, modern fireboat vessels. These limitations slow deployment, hinder maintenance, create safety risks, and reduce overall vessel readiness.

MDRF seeks to modernize and strengthen the lift infrastructure to ensure reliable, mission-ready fireboat operations. With continued growth in cruise activity, commercial shipping, recreational boating, and major marine events, rapid and coordinated maritime emergency response is critical to public safety and regional resilience. Modernized lift facilities will enhance response capability, improve interagency coordination, and support uninterrupted operations during both routine incidents and large-scale emergencies. This project aligns with WAP priorities by promoting safe navigation, protecting economic activity, enhancing interoperability, and strengthening long-term resilience for the region's waterfront communities.

RESOLUTION APPROVING AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR DESIGNEE'S APPLICATION, RECEIPT, AND EXPENDITURE OF GRANT FUNDS OF UP TO \$250,000.00 UPON AWARD FROM THE FLORIDA INLAND NAVIGATION DISTRICT THROUGH ITS WATERWAYS ASSISTANCE PROGRAM TO MIAMI-DADE COUNTY, THROUGH THE MIAMI-DADE FIRE RESCUE DEPARTMENT, FOR UPGRADES TO THE FIREBOAT LIFT SYSTEM AT PORTMIAMI; AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR DESIGNEE'S UTILIZATION OF UP TO \$250,000.00 IN FIRE DISTRICT FUNDS FOR LOCAL PROJECT FUNDING CASH MATCH REQUIREMENTS, EXECUTION OF ALL NECESSARY AGREEMENTS, DOCUMENTS, AND AMENDMENTS, AND EXERCISE OF THE PROVISIONS CONTAINED IN THE AWARD

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying County Mayor's memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Incorporates and approves the foregoing recital, as if fully set forth herein.

Section 2. Approves and authorizes the County Mayor or County Mayor's designee to apply, receive, and expend grant funds, as described in Exhibit A, of up to \$250,000.00 from the Florida Inland Navigation District through its Waterways Assistance Program upon award to Miami-Dade County, through the Miami-Dade Fire Rescue Department ("MDFR"), for upgrades to the fireboat lift system at PortMiami.

Section 3. Authorizes the County Mayor or County Mayor's designee to utilize up to \$250,000.00 in Fire District Funds for local project funding cash match requirements, execute all necessary agreements, documents, and amendments to effectuate the purposes described in section 2, and exercise the provisions contained in the award provided that any amendments are for the purposes described herein and have been approved by the County Attorney's Office for form and legal sufficiency.

Attachment E - Applicant Tips Sheet

(Mistakes Common to the application process and how to avoid them)

SCHEDULING

The new application is available by January each year, and District funding is available AFTER October 1st of each year. Applicants should plan their schedule to avoid commonly missed deadlines: Application due -- 30th of March; Property control/Technical sufficiency items -- 18th of May, Permits -- 21st of September. (Staff suggestion: Begin to secure property control and permits PRIOR to applying for funding.)

PROPERTY CONTROL VERIFICATION

Please have your attorney complete and sign the form in the application verifying applicant property control. In the case of leases or management agreements, please forward a copy to the District well in advance of the deadline to verify consistency with our program rules. (Staff suggestion: Resolve this requirement outside the application "window".)

PROJECT COSTS ELIGIBILITY

Please note the eligible project costs in Rule Section 66B-2.008, F.A.C. If you are not sure about an item's eligibility, ask! Note: Any ineligible cost, including in-house project management and administration, is also not eligible for an applicant's match. Make sure you have delineated your required minimum cost-share on the project cost estimate. (Staff suggestion: If you have questions about the eligibility of an item, work up a mock cost-sheet and send it to our office well before the deadline.)

COST-SHARE

Although the applicant must provide a minimum of 50% of the total project costs (25% for eligible public navigation dredging), there is no specific requirement to split each item. (Staff suggestion: You may want to organize project elements in a certain manner for easier accounting.)

PRE-AGREEMENT EXPENSES

Rule 66B-2.005(3), F.A.C. requires any activity in the submitted project cost estimate occurring PRIOR to October 1st to be considered as pre-agreement expenses. The Board's past philosophy has been to fund only those projects that require District funding assistance to be completed. It is best to avoid pre-agreement expenses if possible. Note: Pre-agreement expenses must be limited to 50% or less of the total project costs, and they are eligible for only ½ of the original District funding. (Example: A project with a total cost of \$200,000 is Board-approved for one-half construction PRIOR to October 1st. In this case, District funding will be limited as follows: Only 50% of the \$100,000 project cost prior to October 1st is eligible as project expenses (i.e. \$50,000). Then only ½ of the eligible project expenses (\$50,000) are eligible for District funding assistance (i.e. \$25,000).

SUBMITTED MATERIALS & JUNE PRESENTATION

The Board must review and evaluate every application and each year we receive about 90 applications for consideration. The final product for the Board's review is two 8-1/2" x 11" spiral-bound notebooks containing the essential information for the application. NOTE: Make sure your final submitted material is the same material you will be presenting to the Board at our June meeting. This will avoid confusion and strengthen your presentation. (Staff suggestion: Limit the submitted materials to the requested information, in the required format and make sure it is consistent with your June presentation. Do not submit additional material at the June presentation!)

ELECTRONIC SUBMISSIONS

Grant applications are ONLY being accepted by email. Grant applications shall be submitted via email as two (2) pdf attachments (15mb max size and see attachment instructions on the next page). Make sure to label your pdf attachments with the applicant and project title. You will receive a confirmation email letting you know that your application has been received. Miami-Dade Fire Rescue (MDFR) is a core partner to local, state, and federal maritime agencies, maintaining 24/7 readiness to protect the County's waterways that support major commercial, industrial, and recreational activity. MDFR's Marine Operations Bureau is solely responsible for fire protection and all hazard emergency response across more than 600 square nautical miles of heavily trafficked inland and coastal waters in eastern South Florida.

MDFR's existing fireboat lift at PortMiami is 17 years old, structurally outdated, and is unable to support the operational requirements of modern, larger fireboat vessels. These limitations slow deployment, hinder maintenance, create safety risks, and reduce overall vessel readiness. MDFR seeks to modernize and strengthen its dock infrastructure to ensure reliable, mission-ready fireboat operations. With continued growth in cruise activity, commercial shipping, recreational boating, and major marine events, rapid and coordinated maritime emergency response is critical to public safety and regional resilience. Modernizing the boat lift facility with a 120k lb lift will enhance response capability, improve interagency coordination, and support uninterrupted operations during both routine incidents and large-scale emergencies.

This project aligns with WAP priorities by promoting safe navigation, protecting economic activity, enhancing interoperability, and strengthening long-term resilience for the region's waterfront communities.

The fireboat lift upgrades fall under Priority 13 as it enhances infrastructure vital for emergency response and waterway safety. MDFR's current lift is outdated and can no longer accommodate the current larger vessels, limiting safe hoisting and rapid deployment. Improvements like reinforced pilings, mooring systems, storm surge protection, and utilities will ensure compliance with marine standards, boosting public safety and navigation resilience.

- c) Explain how the project relates to the District's Waterways and the mission of the Florida Inland Navigation District.

This project will support FIND's mission by enhancing MDFR's ability to respond swiftly and effectively to the growing number of navigational emergencies. Rapid intervention is critical to preventing incidents on the District's waterways from escalating. By reducing the severity of these emergencies, MDFR will not only save lives and minimize property damage, but will also help prevent an increase in submerged and derelict vessels throughout the District's waterways.

MDFR's existing dock and boat lift (60k and 80k pounds) was awarded in 2009 under this program, however the lift is now too small to accommodate newer, larger boats (of up to 120k pounds). The previous project name was "Floating Dock & Boat Lift" The amount of funding received was \$111,150.

5. What is the current level of public access in terms of the number of boat ramps, boat slips and trailer parking spaces, linear feet of boardwalk (etc.) if applicable?

There is no public access at the project site, however, any agency on the water that needs to use the lift can request to use it.

No additional ramps, slips, parking spaces, or other access features will be added by this project.

This project improves public access and navigational safety by ensuring reliable, mission-ready fireboat infrastructure. An upgraded functional 120k pound lift will enable faster response to boat fires, accidents, medical emergencies, and Homeland Security incidents. Modernizing this system supports rapid deployment, reduces on-water risk, and helps keep navigation channels open for all waterway users. Any agency on the water that needs to use the lift can request to use it.

- b) What is the current demand for public access or navigation facilities in the area, and how does this project address unmet needs or improve upon existing facilities?

Current demand for safe public access and reliable navigation infrastructure continues to rise due to expanding cruise operations, commercial shipping, and recreational boating. This project addresses those needs by modernizing critical boat lift infrastructure, improving response efficiency, and enhancing the safety and resilience of navigation for all. MDR's current lift is aging and no longer safely or efficiently supports the weight of today's fireboats, increasing the risk of vessel damage and delaying deployment during emergencies. From FY 2020 to FY 2024, MDR's two fireboats and crews responded to 2,814 incidents, demonstrating the need for dependable maritime response facilities.

- c) How does the project fit within regional or local maritime management plans, public access initiatives, or comprehensive plans, and how does it contribute to broader public usage goals?

This project supports regional maritime plans by strengthening emergency-response infrastructure and protecting public access. With 28 million boating tourists annually and over 100,000 visitors to the Miami International Boat Show annually, the demand for safe waterways is high. A modernized fireboat lift enhances resilience, ensures rapid response, and helps to keep waterways safe and accessible for public use.
