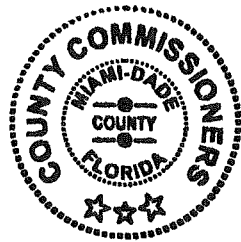
WHEREAS, this Board desires to allocate funds from the FY 2025-26 District 1 CBO Discretionary Reserve in accordance with the attached memorandums,
