WHEREAS, this Board desires to allocate funds from the FY 2025-26 District 13 CBO Discretionary Reserve and the FY 2025-26 District 13 Arena Naming Rights Fund in accordance with the attached memorandums; and

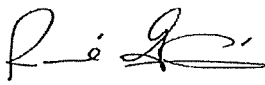
