RESOLUTION AMENDING RESOLUTION NO. R-159-24 AS AMENDED BY RESOLUTION NOS. R-712-24 AND R-452-25 TO REVISE SECTIONS 2 AND 10(A)(3) OF THE INTERLOCAL AGREEMENT BY AND BETWEEN THE CITY OF MIAMI GARDENS AND THE COUNTY DATED JUNE 25, 2024, AS AMENDED BY THE FIRST AND SECOND AMENDMENT TO EXTEND THE PROJECT COMPLETION DEADLINE FOR THE MIAMI GARDENS CITY CENTER PROJECT TO JUNE 30, 2028

WHEREAS, at the May 19, 2026, Board of County Commissioners meeting, a motion was made to amend Resolution No. R-159-24, as amended by Resolution Nos. R-712-24 and R-452-25, and the Interlocal Agreement by and between the City of Miami Gardens and the County dated June 25, 2024, as amended by the First and Second Amendment, to revise Sections 2 and 10(a)(3) to extend the project completion deadline for the Miami Gardens City Center Project to June 30, 2028,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. Resolution No. R-159-24, as amended by Resolution Nos. R-712-24 and R-452-25, and the Interlocal Agreement by and between the City of Miami Gardens and the County dated June 25, 2024, as amended by the First and Second Amendment, is hereby amended to revise Sections 2 and 10(a)(3) to extend the project completion deadline for the Miami Gardens City Center Project to June 30, 2028.

Section 2. The County Mayor or County Mayor's designee is authorized to execute any and all documents and to take all actions necessary to give effect to the amendment described in section 1 of this resolution.
