Subject: Resolution Ratifying the Award of Construction Contract No. S-16136 for the Upgrade of Pump Station 313 and 10-inch Force Main with R&G Engineering, Inc.

Executive Summary

This item seeks ratification by the Board of County Commissioners (the Board) of the action of the County Mayor or County Mayor's designee approving the competitive award of Construction Contract S-16136 (the Contract) for the *Upgrade of Pump Station 313 and 10-inch Force Main* (the Project) with R&G Engineering, Inc. (the Contractor) for a total Contract amount of \$3,786,415.05 and a total Contract term of 495 calendar days. **The Contractor was the lowest responsive and responsible bidder and submitted a bid that was 19% below the Engineer of Record's (EOR's) Opinion of Probable Cost.**

The Project consists of: (1) upgrading Pump Station (PS-0313) to ensure future operational reliability, and (2) installing approximately 2,000 linear feet of 10-inch force main (FM) from PS-0313 to an existing 36-inch FM located at NE 18th Avenue and NE 164th Street.

As part of its \$8.6 billion Capital Improvement Program, WASD is investing in large-scale infrastructure upgrades to increase system capacity, improve operational reliability, and ensure regulatory compliance. The Project includes the construction of critical infrastructure improvements necessary to enhance system performance and support environmental protection. The existing pump station and force main infrastructure are aging and may no longer meet current operational demands or performance standards. Upgrading the pump station and installing a new force main will improve system reliability and reduce the risk of failures, leaks, and unplanned downtime.

Recommendation

It is recommended that the Board ratify the action of the County Mayor or County Mayor's designee, as authorized under Section 2-8.2.12 of the Code of Miami-Dade County (WASD's Acceleration Ordinance), for the funded Project identified below and on Exhibit A.

Scope

The Project will be performed at WASD's PS-0313, located at 2085 NE 164th Street and between NE 18th Avenue and NE 164th Street, in Commission District 2, which is represented by Commissioner Marleine Bastien.

Delegation of Authority

The Contract was awarded pursuant to WASD's Acceleration Ordinance, which delegates authority to the County Mayor or County Mayor's designee to award certain projects, and, among other things, negotiate and settle claims and execute change orders that do not exceed ten percent (10%) of the base contract amount subject to ratification by the Board.

Fiscal Impact/Funding Source

The fiscal impact to the County will be \$3,786,415.05 and will be funded from: Wastewater Connection Charges, WASD Revenue Bonds Sold, and Future WASD Revenue Bonds. There is no impact to the General Fund. The Project is in WASD's Fiscal Year 2025-2026 Adopted Budget and Multi-Year Capital Plan, Pump Stations – Rehabilitation and Resilience Program, Program #2000000784, Volume #3, Page #107.

Track Record/Monitoring

WASD's Deputy Director of Planning, Regulatory Compliance and Capital Infrastructure, Marisela Aranguiz-Cueto, P.E., will oversee implementation of this Contract.

Due Diligence/Safety Information

Due diligence was conducted by WASD and the Strategic Procurement Department (SPD) in accordance with the County's Procurement Guidelines to determine responsibility, including verifying corporate status; performance; safety record, including Occupational Safety and Health Administration (OSHA) records; and compliance data. The lists that were reviewed include: convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings related to the Contractor's responsibility. This information is being provided pursuant to Resolution No. R-187-12.

Background

The Project is critical to ensuring the reliability, efficiency, and compliance of the sewage system infrastructure serving from PS-0313 to an existing 36-inch FM located at NE 18th Avenue and NE 164th Street. It addresses key operational and regulatory requirements by upgrading outdated systems, enhancing capacity, and ensuring environmental protection. The existing PS-0313 and FM are aging and may not meet current demands or performance standards. Upgrading PS-0313 and installing a new FM will significantly enhance the system's reliability and will reduce the risk of failures, leaks, or unplanned downtime.

The Award was filed on December 15, 2025, and the Contract was fully executed and attested by the Clerk's Office on March 27, 2026.

On September 3, 2014, the Board approved Ordinance No. 14-77 authorizing the County Mayor or County Mayor's designee to award contracts for funded capital projects and related goods and services, and to accelerate the approval of WASD's: (1) Consent Decree projects, and (2) projects identified in WASD Multi-Year Capital Plan's Capital Improvement Program without the need for prior Board approval but subject to ratification by the Board.

Executive Summary

This memorandum seeks approval of the award of Contract No. S-16136, Upgrade of Pump Station 313 and 10-inch Force Main ("the Contract"), to R&G Engineering, Inc. (R&G Engineering). The project is for the upgrade of Pump Station (PS) 0313 and the installation of approximately 2,000 linear feet of 10-inch force main (FM) from PS 0313 to an existing 36-inch FM located at NE 18th Ave. and NE 164th St. These upgrades will ensure future operational reliability and mitigate potential failures.

Recommendation

It is recommended that the Contract be awarded to R&G Engineering for a total compensation amount of \$3,786,415.05, with a total Contract period of 495 days, which consists of 390 calendar days to Substantial Completion, 450 calendar days to Final Completion, and a 45-day Contingency Time Allowance.

Scope

The Contract will be performed at 2085 NE 164th Street, North Miami Beach, FL 33162 and along NE 164th Street from NE 18th Avenue to NE 20th Avenue in District 2, which is represented by Commissioner Marleine Bastien.

Delegated Authority

The Project is a Capital Improvement Contract being processed under Section 2-8.2.12 of the Miami-Dade County Code (WASD's Acceleration Ordinance). Pursuant to Sections 2-8.2.12 (4)(d) and (e) of the Code, the County Mayor or County Mayor's designee has the authority to, among other things, amend and/or extend the Contract to complete any unfinished work, waive liquidated damages, negotiate and settle claims, and execute change orders that do not exceed ten percent (10%) of the base Contract amount, subject to ratification by the Board of County Commissioners (the Board).

Fiscal Impact/Funding Source

The fiscal impact to the County is \$3,786,415.05, which WASD has determined is a fair and reasonable amount for the Project's defined scope of work.

The Project is in the Fiscal Year 2025 – 26 Adopted Budget and Multi-Year Capital Plan.

- Funding will be provided from Program #2000000784, Pump Stations – Rehabilitation and Resilience Program Volume 3 Page 107.
- The funding sources are Wastewater Connection Charges, WASD Revenue Bonds Sold, Future WASD Revenue Bonds.
- The project does not include GOB funding.

The following due diligence was performed to determine that R&G Engineering was the lowest responsive and responsible bidder:

- There were no Small Business Development (SBD) contract measures assigned to the Contract. The Project Worksheet from SBD is attached to this memo as Exhibit A.
- Lauren Johnson of Thompson & Associates, the Engineer of Record (EOR), reviewed the bid submission and, on October 16, 2025, determined that the low bid was acceptable as submitted and that R&G Engineering satisfied the requirements of the solicitation. The EOR letter is attached to this memo as Exhibit B.
- Pursuant to Resolution No. R-187-12, WASD performed a review of the vendor information in the Business Management Workforce System (BMWS). WASD discovered no adverse information.
- According to the contractor history downloaded from the BMWS on November 21, 2025, over the past five (5) years, R&G Engineering has been awarded eighteen (18) contracts from the County for a total of \$28,169,276.00.
- R&G Engineering has sixty-eight (68) evaluations in the ISD Capital Improvement Information System (CIIS), with a rating of 3.1 out of a possible 4.0 maximum.

Considering the input of ISD and the EOR, WASD has concluded that the apparent lowest bidder, R&G Engineering, is both responsive and responsible. The total bid of \$3,786,415.05 is 19% below the EOR's estimate of \$4,662,355.97; the bidder has a 3.1 rating in CIIS; and there are no protests, thereby qualifying for an award under the Acceleration Ordinance, subject to ratification by the Board. Therefore, it is recommended that Contract No. S-16136 be awarded to R&G Engineering for a total compensation amount of \$3,786,415.05, with a total Contract period of 495 days. The proposed Contract, signed by R&G Engineering, is attached to this memo as Exhibit C.

Dear Mr. Adams,

Following the formal evaluation of bids received for the above-referenced solicitation, we are pleased to submit our recommendation for award.

The bid submitted by R&G Engineering, Inc. (R&G) was determined to be the lowest responsive and responsible bid. Upon review, the unit pricing across the scope of work was found to be reasonable and within expected market ranges.

Our technical evaluation indicates that R&G possesses the **capacity, experience, and qualifications** necessary to perform the required services in accordance with **WASD standards** for the 10-inch force main installation. While R&G did not fully satisfy the contract requirement for three (3) completed projects of similar scope and size within the past five (5) years as prime consultant, we find them **qualified to perform the work** based on the following considerations:

- **Additional employee qualifications** submitted by R&G on October 15, 2025 demonstrated significant relevant experience of key staff.
- **Extensive relevant project experience** beyond the five-year threshold, including work performed as subconsultants.
- **Positive testimonials** from WASD staff members Mr. Juan Curial and Mr. David Vazquez during the S-16136 Responsibility Review meeting held on October 9, 2025, attesting to R&G's satisfactory past performance on previous contracts with Miami-Dade County.

Based on these findings, it is our professional recommendation that Miami-Dade County award the contract to R&G Engineering, Inc., subject to final contract negotiations and approval.

THIS CONTRACT, made and entered into on the ___ day of _____, 20___, by and between Miami-Dade County, Florida, acting by and through the Office of the Mayor, party of the first part (hereinafter sometimes called the "County"), and R&G Engineering, Inc., party of the second part (hereinafter sometimes called "Contractor");

WITNESSETH

That the parties hereto, for and in consideration of the covenants and agreements hereinafter set forth, mutually agree as follows, to wit:

1. That the Contractor shall furnish all labor, materials and equipment and perform all work in the manner and form provided by the Contract Documents covering the Project of the County known and identified as

for the aggregate amount reflected by the Proposal, said aggregate amount being of **Three Million, Seven Hundred and Eighty-Six Thousand, Four Hundred and Fifteen Dollars and No Cents (U.S. Dollars) \$3,786,415.05.**

2. That the Contractor shall begin the work to be performed under this Contract on a day to be specified in a written order issued by the Engineer and shall fully complete all work hereunder within the time or times stated in the Proposal.

3. That the County shall pay to the Contractor for the faithful performance of this Contract, in lawful money of the United States, and subject to additions and deductions as provided in the Contract Documents, the total amount of the Proposal as set forth above at the times and in a manner stated in the General Contract Conditions of the Contract Documents.

4. It is further mutually agreed that if at any time after the execution of this Contract, Surety Performance and Payment Bond, the County shall deem the surety upon such bonds to be unsatisfactory, or if for any reason such bond shall become inadequate to cover the performance of the work, the Contractor shall at its own expense, within five (5) days after the receipt of notice from the County to do so, furnish an additional bond or bonds in such form and amount and with such surety or sureties as shall be satisfactory to the County. In such event, no further payment to the Contractor shall be deemed to be due under this Contract until such new or additional security shall have been furnished in a manner and form satisfactory to the County.

5. The "Contract Documents" are hereby defined as the Advertisement for Bids, Questionnaire, Instruction to Bidders, Proposal, Certified Resolution for Proposal and Bid Form, Bid Bond, all forms submitted pre and post award, including, without limitation, Miami-Dade County Vendor Affidavits Form, Sworn Statement – Public Entity Crimes, Clearinghouse Affidavit, Job Order Request form, and the Small Business Enterprise Programs Participation Provisions and Forms (if applicable), this Contract, Certified Resolution for Contract and Performance and Payment Bond, Performance and Payment Bond, Standard Construction General Contract Conditions, revised August 1, 2023, the Technical Specifications, Plans and Drawings designated in the specifications, all Technical Appendices, all Addenda, Water & Sewer Department Special

CONTRACT

Provisions, Change Orders to the Contract, Notice to Proceed, Referenced Codes and Standards, Warranties and Guarantees, all related correspondence, field notes, logs, and other documents.

The Standard Construction General Contract Conditions of said Contract Documents are incorporated herein by reference and made a part hereof as though fully set forth herein. The Contract Documents are complementary, so that a recital in one is tantamount to a recital in all, and the Contractor specifically acknowledges that it has read and understands all of said Contract Documents.

6. The various indemnities of the Contractor contained in the Contract Documents indemnifying the County from liability for damages to persons or property caused by acts, omissions, or defaults in the performance of the Contract Documents shall have a monetary limitation of the larger of the following: \$1,000,000.00, or the entire amount of the Contract.

7. The County retains the right to audit any and all information regarding this Contract as described in the Standard Construction General Contract Conditions, Article 12 G (Miscellaneous Provisions – Audit Rights)

8. Notwithstanding and prevailing over any other provision of the Contract Documents to the contrary, the County Mayor or his designee, may exercise the provisions of Section 2-8.2.12 (4)(d) and (e) of the Code of Miami-Dade County. Any change orders or amendments shall not exceed 10 percent of the base contract price in cumulative percentage amount; provided however, that the foregoing limitation shall not apply to any change order or amendment related to emergency actions impacting remediation, public safety, health requirements or recovery from natural disaster and the foregoing change orders and amendments shall require ratification by the Board; provided further that the County Mayor or his designee may reduce in any amount the scope and compensation payable under this Contract and grant compensable and non-compensable time extensions thereunder. Pursuant to Section 2-8.2.12 (5), the Mayor or the Mayor's designee's award and execution of this Contract is subject to ratification by the Board of County Commissioners. If the Mayor or the Mayor's designee's action is not ratified, and such legislative action becomes final, this Contract shall be deemed terminated without further notice. In such event, the Contractor shall not be entitled to recovery of any lost profits or other consequential or indirect damages. However, the Contractor is eligible for payment for any work done prior to failure of the ratification, in accordance with General Contract Conditions Article on Termination for Convenience.

9. "Contract Execution Date" means the date of the last signature on this contract.

Any change orders or amendments shall not exceed 10 percent of the base contract price in cumulative percentage amount; provided however, that the foregoing limitation shall not apply to any change order or amendment related to emergency actions impacting remediation, public safety, health requirements or recovery from natural disaster and the foregoing change orders and amendments shall require ratification by the Board; provided further that the County Mayor or his designee may reduce in any amount the scope and compensation payable under this Contract and grant compensable and non-compensable time extensions thereunder. Pursuant to Section 2-8.2.12 (5), the Mayor or the Mayor's designee's award and execution of this Contract is subject to ratification by the Board of County Commissioners. If the Mayor or the Mayor's designee's action is not ratified, and such legislative action becomes final, this Contract shall be deemed terminated without further notice. In such event, the Contractor shall not be entitled to recovery of any lost profits or other consequential or indirect damages. However, the Contractor is eligible for payment for any work done prior to failure of the ratification, in accordance with General Contract Conditions Article on Termination for Convenience.

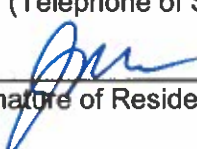
