RESOLUTION APPROVING ALLOCATIONS FROM THE FY 2025-26 DISTRICT 2 CBO DISCRETIONARY RESERVE, THE FY 2025-26 DISTRICT 2 DESIGNATED PROJECT PROGRAM, AND THE FY 2025-26 DISTRICT 2 ARENA NAMING RIGHTS FUND; RESCINDING AN ALLOCATION FROM THE FY 2025-26 DISTRICT 2 CBO DISCRETIONARY RESERVE; AND WAIVING THE REQUIREMENTS OF RESOLUTIONS NO. R-238-21 AND R-243-23 AS RELATED TO THE ALLOCATION FROM THE ARENA NAMING RIGHTS FUND

WHEREAS, this Board desires to (1) allocate funds from the FY 2025-26 District 2 CBO Discretionary Reserve, the FY 2025-26 District 2 Designated Project Program, and the FY 2025-26 District 2 Arena Naming Rights Fund and (2) rescind an allocation from the FY 2025-26 District 2 CBO Discretionary Reserve in accordance with the attached memorandums; and
