- 1) Using the table above as a guide for families/households with more than eight (8) members, add \$5,500 for EACH additional family/household member.
- 2) The Miami-Dade County Ryan White Program Provide® Enterprise Miami data management system will be programmed according to these guidelines, effective March 1, 2025 through February 28, 2026.
- 3) Income eligibility for the following Ryan White Part A and Minority AIDS Initiative (MAI) Program-funded services in Miami-Dade County is limited to program-eligible clients who have a gross household income at or below 400% of the Federal Poverty Level (FPL). The 400% FPL income limit applies to all locally-funded Ryan White Part A and MAI Program service categories, except Food Bank services whose limit is 250% of the FPL.
- 4) Please be advised that this document is simply an internal reference tool and the rounding calculations may be slightly off. Percentage calculations in the table above are rounded to avoid gaps between whole number dollar amounts. The first number for each household size in column A is exact per the HHS Poverty Guidelines for 2025, as are the calculations in the Provide® Enterprise Miami data management system.
