ADDENDUM 1

The following clarifications and additions are related to the FY 2023 Community Development Block Grant (CDBG) Home Investment Partnerships Program (HOME) and Emergency Solutions Grant (ESG) Request for Applications (RFA) published on March 28, 2023. PHCD's responses below become a part of the guidance for the above listed RFAs.

- 1. The list of attachments on Page 3 of the Community Development Block Grant (CDBG) application was corrected to number the attachments 1 to 25 consecutively.
- 2. The minimum eligibility requirements on Pages 12-13 of the CDBG application are revised as follows:
 - Applicants that apply for more than 20% of the total funds available in any one category (i.e., Public Service, Economic Development, Public Service Technical Assistance to Small Businesses) will not be recommended for funding, as determined at the County's sole discretion, and to ensure geographic coverage throughout Miami-Dade County.

 Applicants that apply for more than 50% of the total funds available in any one category (i.e. Economic Development Technical Assistance to Businesses, Economic Development Micro Enterprise Lending and Special Economic Development Lending, Economic Development Business Incubator Assistance Program) will not be recommended for funding, as determined at the County's sole discretion, and to ensure geographic coverage throughout Miami-Dade County.
- 3. The Housing Resource Guideline Allocations funding amounts for activities/categories on Page 4 of the Emergency Solutions Grant (ESG) application are revised as follows: Homeless Emergency Shelter \$389,276.26 \$583,914.39 Homeless Prevention and Rapid Rehousing \$583,914.39 \$389,276.26
- 4. The Housing Resource Guideline Allocations funding amounts for activities/categories on Page 29 of the Home Investment Partnerships Program (HOME) application are revised as follows:
 - HOME CHDO Operating Support \$50,000 \$100,000.00 is available when attached to an awarded HOME project, including prior year awarded HOME projects.
 - HOME Multifamily Development (not part of this RFA, will be made available in the FY 2023 Surtax/SHIP/HOME Request for Applications) \$8,023,928.73 \$7,973,928.73
- A space was added in the HOME application in ZoomGrants (Question 8 in the Application Cover Sheet tab) to allow applicants to enter in the amount of HOME CHDO Operating Support funding requested.
- 6. The following statement was added to Question 8 in the HOME application in ZoomGrants: HOME CHDO Operating Support funds can be requested along with HOME CHDO Set-Aside funds for a new activity or a currently funded HOME CHDO activity that has not commenced construction.
