Clark Center, 111 NW 1st Street, Miami, Florida 33128.** The purpose of the hearing is to allow the public an opportunity to comment on the following:

- Substantial amendment to the FY 2021 Action Plan and corresponding FY 2020-24 Consolidated Plan in order to allocate \$1,017,500.00 of Home Investment Partnerships Program Income to Centennial Management Corporation, or related entity, for the development of Princeton Crossings, a 150-unit affordable housing community located at 13841 SW 252nd Street, in unincorporated Miami-Dade County Florida.
