Subsequently, the actions described below will be considered for final action by the BCC on **Tuesday, November 1, 2022, at 9:30 a.m.** Both meetings will be held inside Board of County Commission Chambers located on the second level of the Stephen P. Clark Center, 111 NW 1<sup>st</sup> Street, Miami, Florida 33128. The purpose of the hearing is to allow the **public an opportunity to comment** on the following:

- Substantial amendment to the FY 2021 Action Plan and corresponding FY 2020-24 Consolidated Plan in order to allocate \$1,017,500.00 of Home Investment Partnerships Program Income to Centennial Management Corporation, or related entity, for the development of Stadium Towers, a 149-unit affordable housing community located at the northwest corner of NW 23<sup>rd</sup> Street and 8<sup>th</sup> Avenue, in Miami, Florida, 33127.
