Public Housing and Community Development (PHCD) will hold a public hearing on **March 27, 2023 via ZOOM at 2:00 pm. The public may also attend in person at the Overtown Transit Village (OTV) 1st floor Training Room, 701 NW 1st Court, Miami, Florida 33136.** The purpose of the hearing is to allow the public an opportunity to comment the following:

- Substantial Amendments to the FY2019 Action Plan and Corresponding FY 2013-2017 Consolidated Plan, as extended through FY2019 to:
- Recapture a total of \$1,260,800.00 in CDBG-CV3 funds from Career Source of South Florida, Inc. Job Training program (\$558,534.41), Career Source of South Florida, Inc. Summer Youth program (\$14,465.59), Miami-Dade County Community Action and Human Services Department Homeownership Rehabilitation program (\$500,000.00), and Miami-Dade County Public Housing and Community Development CDBG-CV program administration (\$187,800.00)
- Reallocate a total of \$1,260,800.00 in CDBG-CV3 funds to the following public service activities: \$500,000.00 to Miami-Dade County Parks, Recreation and Open Spaces Department for the Fit 2 Lead program, \$573,000.00 to Greater Miami Service Corps for the Summer Youth Afterschool program for persons impacted by the COVID-19 pandemic, \$150,000.00 to Miami-Dade County Community Action and Human Services Department for the Housing Advocacy program, and \$37,800.00 to Keeping the Bleau Green Committee, Inc. for the Seniors Asking for Technological Assistance program.
