

NOTICE OF PUBLIC HEARING AND 30-DAY COMMENT PERIOD ON THE PROPOSED SUBSTANTIAL AMENDMENT TO THE FY 2013-17, AS EXTENDED CONSOLIDATED PLAN, CITIZENS' PARTICIPATION PLAN FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), HOME INVESTMENT PARTNERSHIPS PROGRAM (HOME), AND EMERGENCY SOLUTIONS GRANT (ESG) PROGRAM FUNDS

Miami-Dade County is considering a proposed substantial amendment to Citizens' Participation Plan, within the 2013-2017, as extended Consolidated Plan. The draft substantial amendment will be available for public review during a 30-day comment period, from December 21, 2019 through January 21, 2020.

The Housing Social Services and Economic Development (HSSSED) Committee will hold a public hearing on January 13, 2020 at 9:30 a.m., or the next regularly scheduled HSSSED meeting due to lack of quorum or deferral. The public hearing will be held inside Board of County Commission Chambers located on the second level of the Stephen P. Clark Center, 111 NW 1st Street, Miami, Florida 33128.

The purpose of the hearing is to give the public an opportunity to comment on the proposed substantial amendment. The public is invited to attend and comment. The proposed Substantial Amendment to the FY 2013-17, as extended Consolidated Plan Citizens' Participation Plan, includes dissolving the Model City Community Advisory Committee, and making modifications to the Citizen Participation election process.
