Students must:

- Be currently enrolled in an undergraduate or graduate program in an accredited College or University and have completed a minimum of 60 semester credits at the time of application.
- Submit an **official transcript** directly from the educational institution to the County prior to the interview date.
- Submit a **resume.**
- Be available for an interview with the Selection Committee.
- Be available to work 20-30 hours a week.
- Complete a criminal history pre-employment background screening.

Construction Contracts Division

Data Analyst (1 opportunity): Responsible for collecting, cleaning, analyzing and interpreting data for the Construction Contracts Division (CCD). Works with CCD team to analyze data and provide insights. Provides data-based reports.

Compliance Management Division

Compliance Management (1 opportunity): The intern's responsibilities will include: assisting with performing review/audit of New Business Division Activities, including various commercial and residential properties for compliance with Chapter 24 of the County Code using verification/research and applying audit procedures to confirm proper and/or corrections regarding Connection Charges; performing research related to the Internal Compliance Department (ICD) audit items; conducting Davis-Bacon Act (DBA) and Davis-Bacon Related Acts (DBRA) interviews and employee salary verification/reconciliation using the LCP tracker; assisting with the preparation of Administrative Standard Operating Procedures (SOPs); support team members with administrative/technical tasks; participating in meetings and contributing to discussions, and other duties as assigned.

Hydrogeology Technical Services Division

Hydrogeology Engineer (1 opportunity): The WASD Hydrogeology internship is designed for students with interest in geosciences and will provide students with experience in various field work such as groundwater sampling and well drilling in addition to data analysis, GIS mapping, and modeling.
