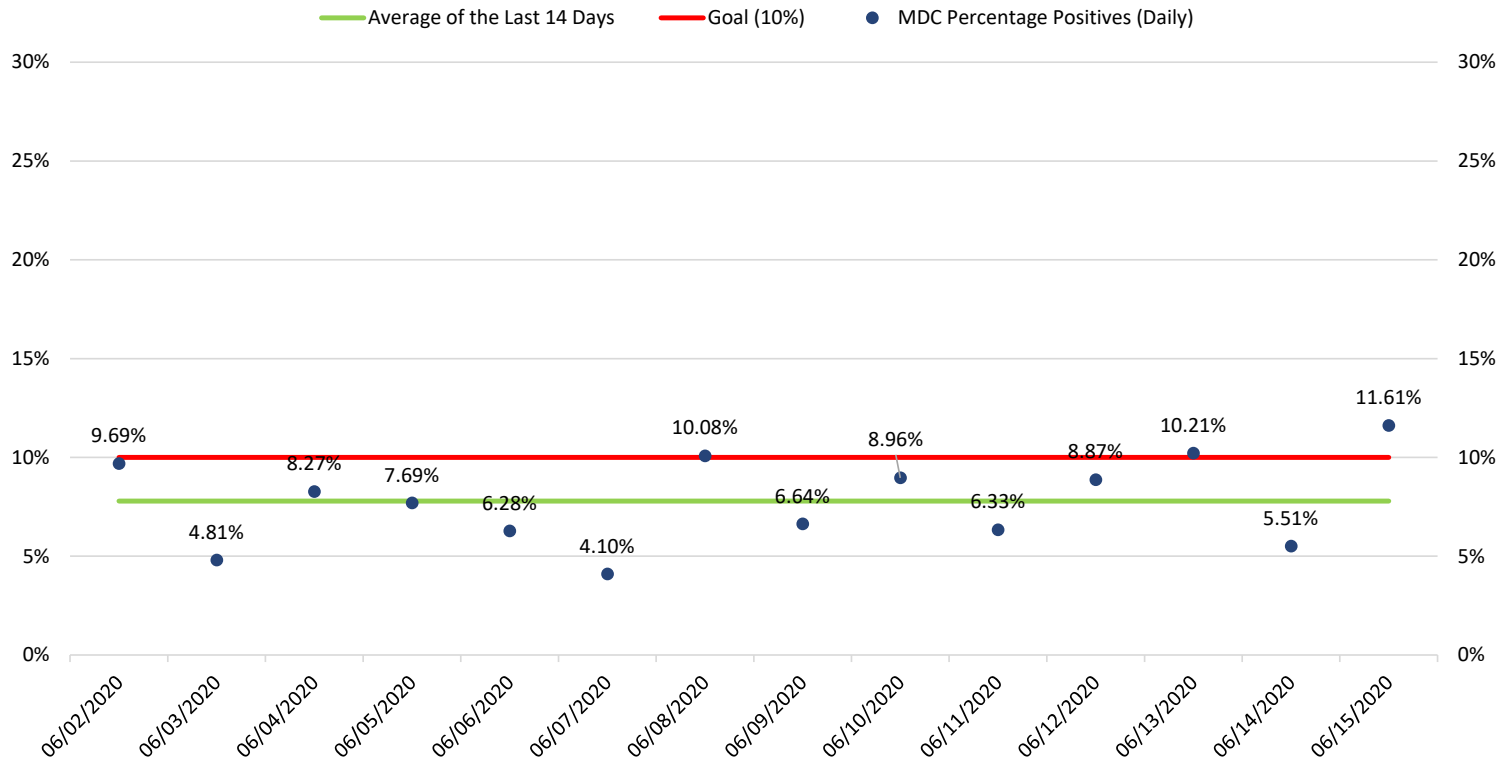

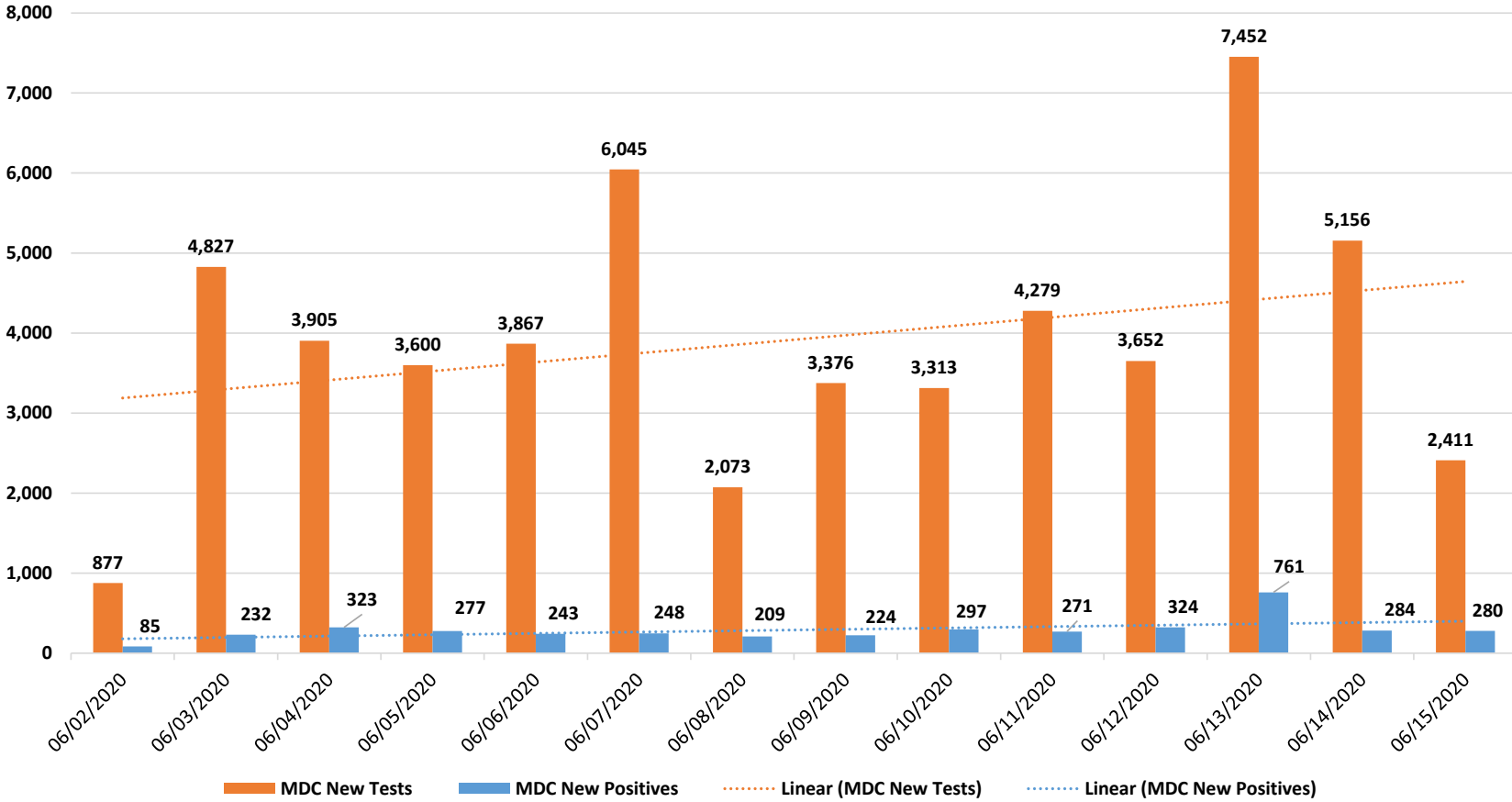
# Daily Positive Cases out of Total Tests

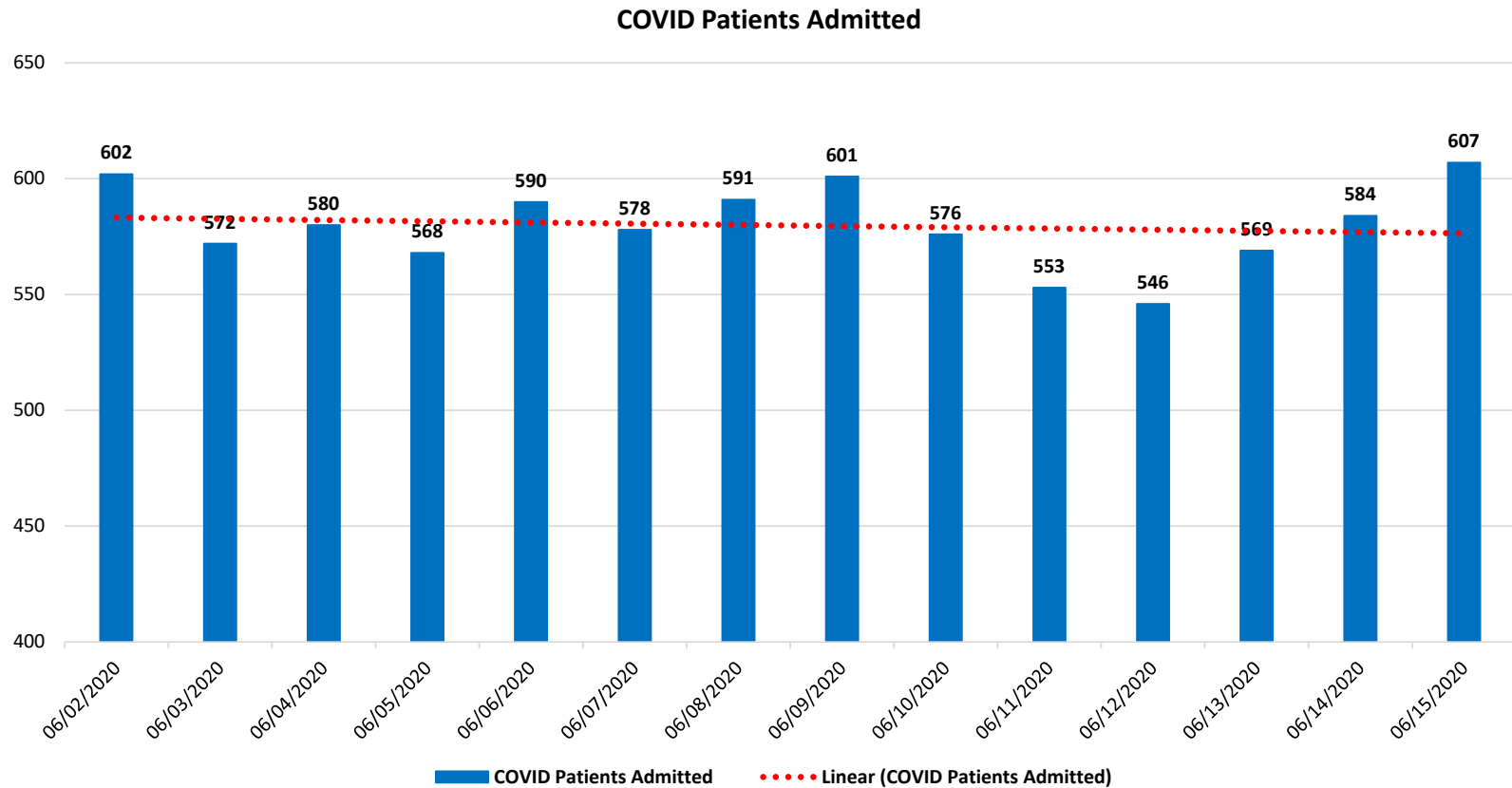

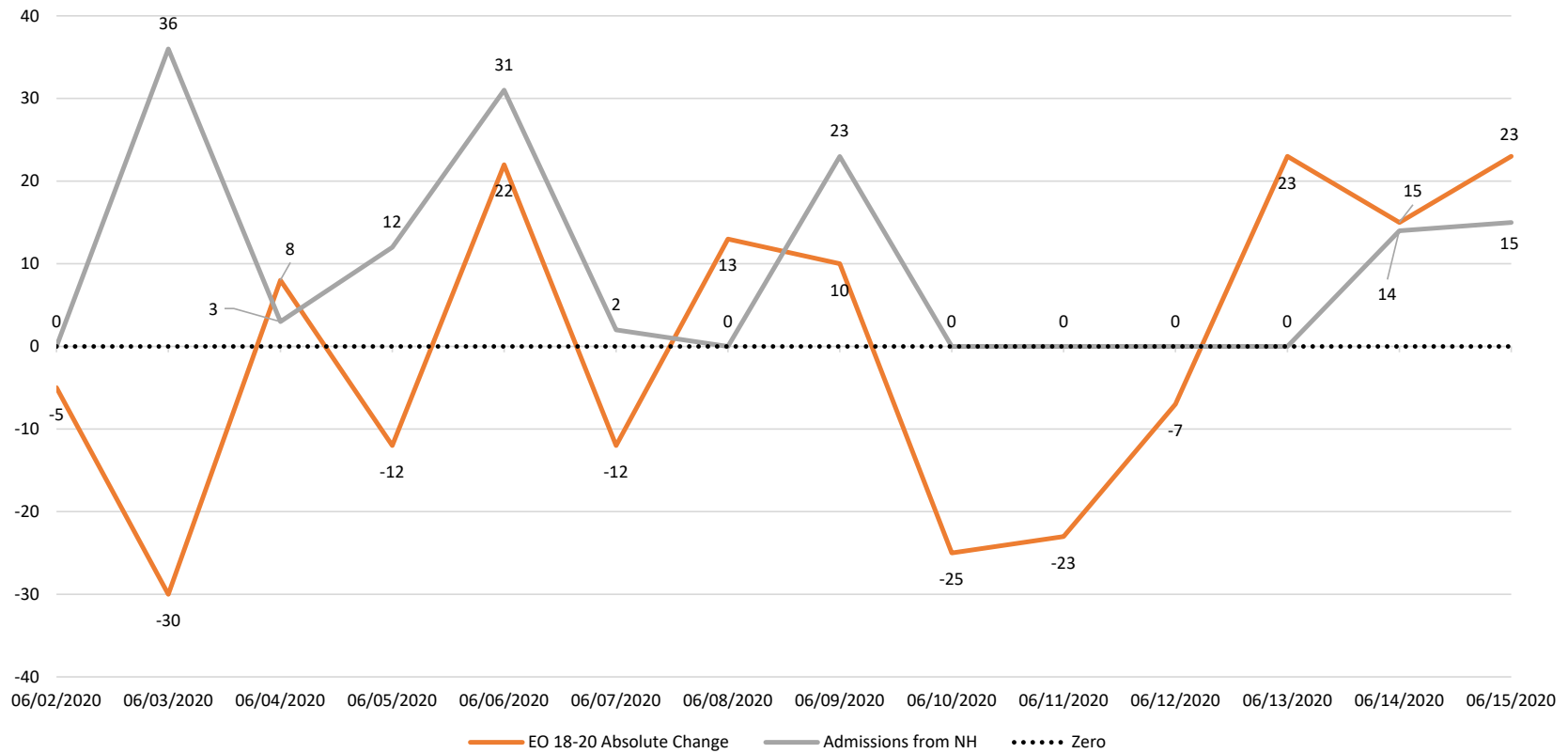
# COVID-19 Admitted Patients

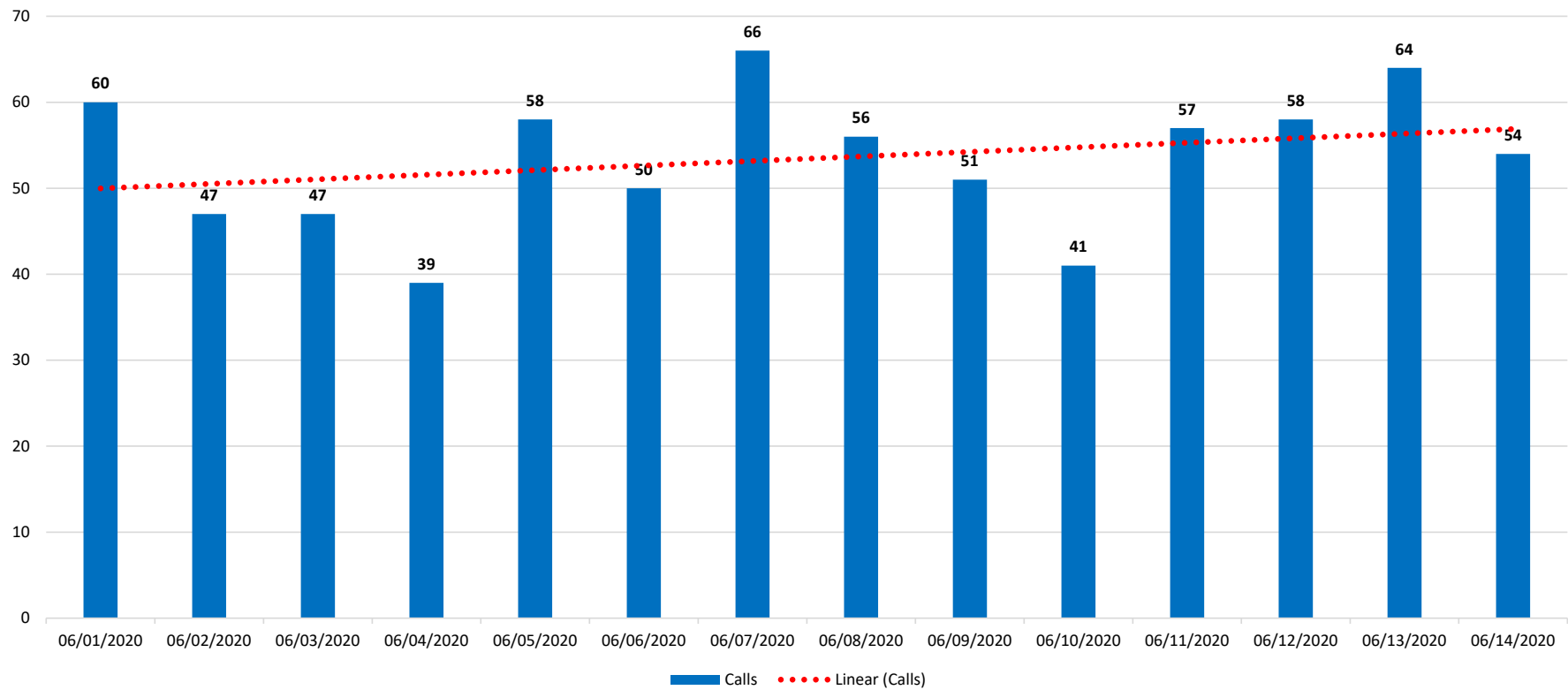

# Miami-Dade Fire Rescue Calls

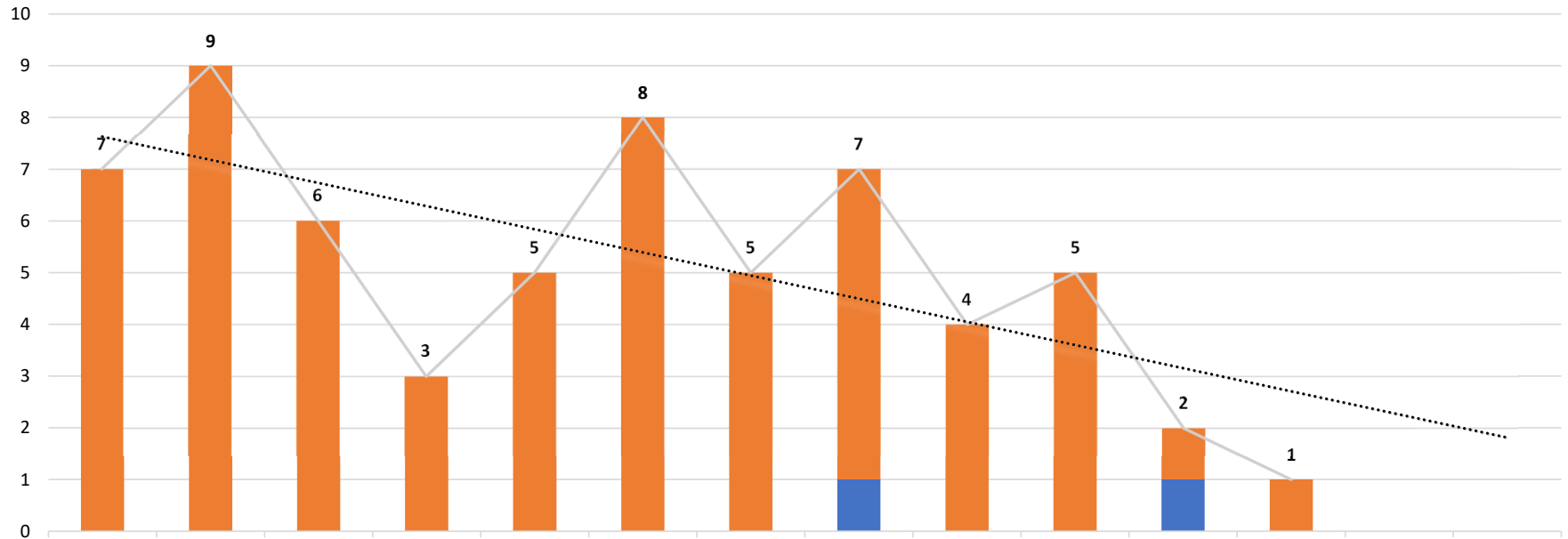
## MDFR Suspected COVID-19 Calls
