## **JOB-RELATED TASK ASSESSMENT**

### **INTRODUCTION**

The Job-Related Task Assessment (JTA) you are about to take is comprised of numerous obstacles that an officer may encounter within the course of duties. These obstacles may challenge your physical strength and endurance, balance, flexibility, agility, and cardiovascular fitness. The JTA requires maximum effort and pacing yourself will be important for the successful completion of the test. The time it takes to complete the test will be recorded as your test effort.

### **HYDRATION AND NUTRITION**

On your test date, you are to report to the testing area, hydrated and prepared to take the test. The Miami-Dade Public Safety Training Institute (MDPSTI) is not responsible for providing water or food prior to, during, or after the JTA. Candidates should consume plenty of fluids 2-3 days prior to testing and a light meal 2-3 hours prior to testing. Candidates should bring additional water and food to be consumed at the completion of their testing.

### **YOUR BEST EFFORT IS ENCOURAGED! PACE YOURSELF AND GOOD LUCK!**

The JTA measures specific physical abilities through participation in a series of tasks which are listed as follows:

The test is conducted in a continuous manner resulting in a total composite score.

### **EVALUATION**

To receive a passing score, the candidate must complete the JTA in a time of **7 minutes, 57 seconds or less.**

### **INFORMATION**

#### **Scheduling**

- All JTA appointment dates and times are scheduled only to qualified police officer applicants by the Personnel Management Bureau
- The JTA is only administered at the Miami-Dade Public Safety Training Institute (MDPSTI) located at 9601 NW 58 Street, Doral, Florida 33178 (See map on page 7)
- The JTA is administered by appointments only

#### **Reporting Information**

When reporting for the JTA, you MUST report 15 minutes prior to the scheduled time in appropriate exercise attire. The west side entrance of the MDPSTI is on NW 97 Avenue which is indicated as #1 on the map. The test will be administered in the area designated as #4 on the map.

You MUST bring the following items:

- The attached Physician's Medical Consent Form (completed and signed by a Physician)
- JTA Data Sheet
- Government Issued Picture ID (i.e. Driver's License, Passport, Military ID, etc.)
- Receipt of payment from the MDPSTI Basic Training Section

*Note: Candidates will not be allowed to participate in the JTA without the aforementioned items.*

#### **No Exceptions.**

#### **Scoring**

The minimum standard for a passing score is 7 minutes, 57 seconds (7:57) and will be provided to candidates immediately following the test.

#### **Fees**

The cost of the JTA is \$45. All JTA fees are non-refundable and non-transferable.

Applicants are prohibited from:

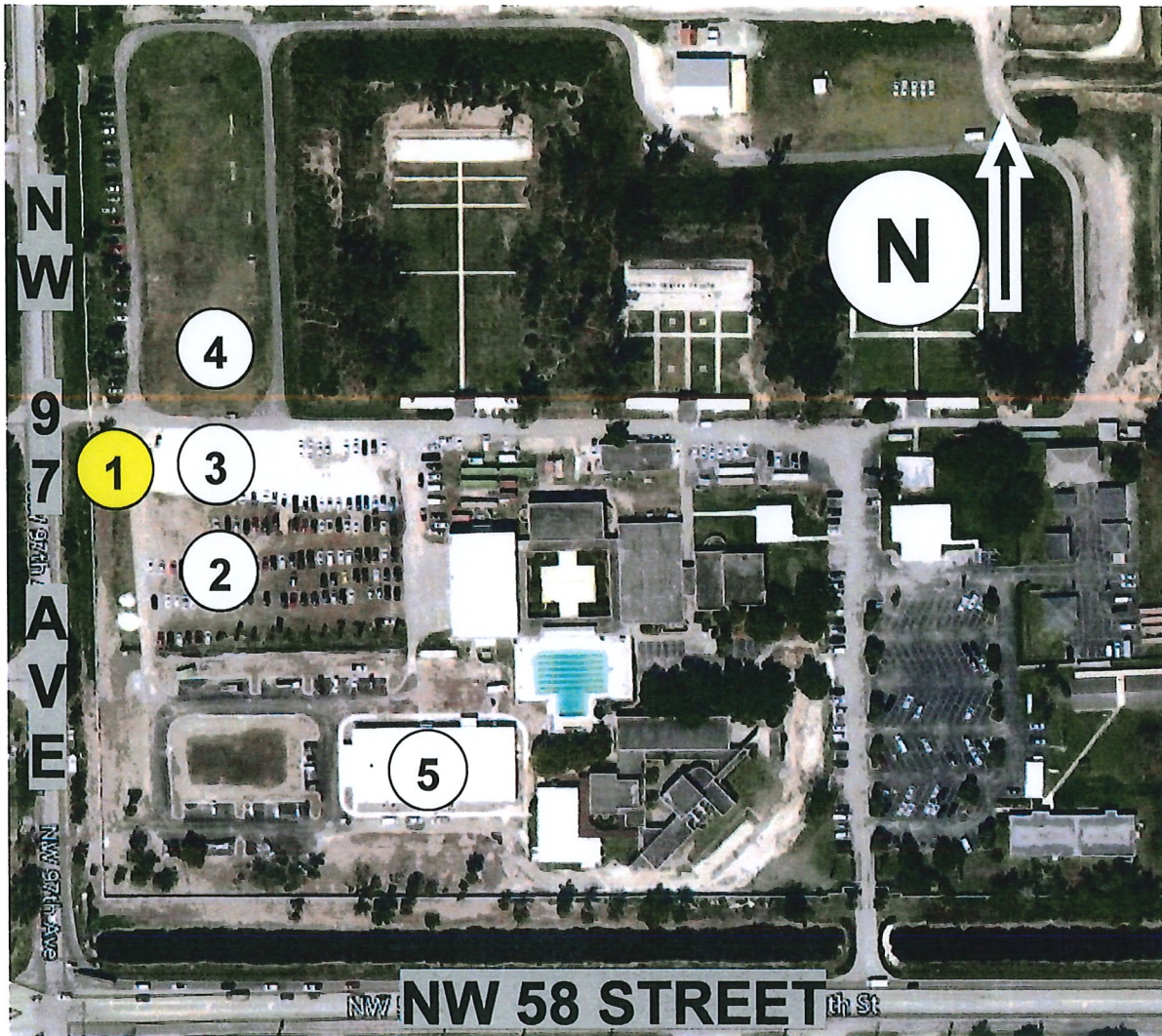
- Wearing headphones, ear buds or any other listening or communication device that has the potential to obstruct audible instructions

- Pacing, running alongside of or cheering on another applicant
