

Miami-Dade County's Natural Forest Community Permit Application Package

The Benefits of Natural Forest Communities

Plants native to Miami-Dade County's Natural Forest Communities are biologically adapted to our climate, soil, and weather patterns.

A yard with native landscape will reduce your water consumption, therefore saving you money on your water bill.

A well-forested community can reduce storm water runoff by up to 15%.

Miami-Dade's trees and understory plants remove 5,425 tons of carbon dioxide from the air each year, improving air quality and combating global warming.

Trees and understory plants provide food, nesting sites and protection for a wide variety of wildlife including migratory birds, thus promoting biodiversity and a healthy ecosystem.

Native plants present property owners with a variety of benefits, whether your interest is beautification, water conservation, reduction of harmful chemicals in the landscape, wildlife habitat, or the preservation of our natural heritage.

NFC General Information

Section 24-49 of the Miami-Dade County Code mandates the protection of the County's trees and forest resources. The following information should assist you in understanding Miami-Dade County's tree and forest protection requirements.

Please take the time to read this information carefully before filling out the attached application.

What is a Natural Forest Community (NFC)?

A Natural Forest Community is a stand of trees (including their associated understory) designated by the Board of County Commissioners, pursuant to Resolution Nos. R-1764-84 and R-1279-97 and shown on the official Natural Forest Community maps that are maintained by Miami-Dade County.

How do I know if my property contains a designated Natural Forest Community?

The DERM Forest Resources Program maintains all the Natural Forest Community Maps and information. Resolution Nos. R-1764-84 and R-1279-97, which list all county designated NFCs, are also kept in the Clerk's Office. To determine if any portion of a property has been designated a Natural Forest Community, please contact the DERM Forest Resources Program at (305) 372-6864 for a verbal determination at no cost to you. No work is to be done within the NFC until a permit is issued.

Why are Natural Forest Communities (NFC's) protected?

The pine rockland and rockland hammock forests of Miami-Dade County are considered unique, rare and globally imperiled ecosystems. They provide habitat for many rare and endemic plant and animal species. Pine rocklands contain the highest plant diversity of any other habitat in Florida. As of 1984, less than 3% of this habitat remained outside of Everglades National Park in Miami-Dade County. The protection afforded to these Natural Forest Communities (NFC) by Chapter 24 of the Miami-Dade County Code is an attempt to preserve the last remaining fragments of Natural Forest Communities (NFC) in Miami-Dade County.


Why is an NFC permit required?

The permitting process is necessary to eliminate avoidable impacts and minimize unavoidable impacts to trees and associated understory plant communities within Natural Forest Communities (NFC). The goal of the program is to maintain the benefits of a healthy forest community. We aim to maximize, to the greatest extent, the preservation and management of all County-designated NFCs.

How do I care for and maintain my Natural Forest Community?

One of the major threats to Natural Forest Communities is invasive exotic plants. The control and elimination of these plants is necessary in order to maintain the health and biodiversity of Natural Forest Communities. If you have NFC on your property you may qualify for an Environmentally Endangered Lands (EEL) Covenant. The EEL Covenant is a voluntary program that provides property owners with an economic incentive in the form of a reduction in property taxes in exchange for preserving and maintaining environmentally-sensitive forested lands under a DERM-approved management plan. Natural Forest Community Permitting Information

When is the Natural Forest Community permit required?

A Natural Forest Community permit is required County-wide for **any work**, including removal of exotic species, in any designated Natural Forest Community (i.e. pinelands, hardwood hammocks). Through the permitting process, DERM verfies that the proposed work meets code requirements and may require the property owner to modify a site plan to preserve tree and forest resources.

Who may apply for a Natural Forest Community permit?

According to Chapter 24-49.1 of the Miami-Dade County Code, an owner, agent of the owner, or lessee of the property may apply for a permit. If the permit applicant is a lessee or agent of the owner, a statement from the owner of the property indicating that the owner has no objection to the proposed work shall be submitted along with the application.

What are the different NFC permit types?

- 1. NFC Removal Permit -is a permit that allows for the clearing of NFC, consituting a permanent impact. This permit is for property owners who wish to develop their property, with limitations outlined in Chapter 24-49 of the Miami-Dade County Code. A certain percentage of the NFC may be approved for removal if the property owner justifies that reasonable use of the property is otherwise not possible.
- 2. NFC Exotic Removal Permit -is a no-fee permit that allows for exotic vegetation removal work and other management activities to be conducted within the NFC.

Permit applications for work in a Natural Forest Community must include the following items:

- 1. A signed and completed Natural Forest Community permit application form. Upon receipt of an application to do work within a Natural Forest Community (NFC), DERM biologists will inspect the site to verify that it meets the definition of a NFC.
- 2. All required application and initial assessment fees.
- 3. For NFC removal permits, a copy of a site plan. Site plans submitted for development actios on properties containing NFC shall graphically show the extent of the current NFC boundaries and shall also contain a tabulation of the total acreage of NFC, NFC acreage proposed for removal and the acreage of NFC to be preserved. The site plan must also show proposed structures including accessory buildings and proposed site improvements, such as: setbacks, driveways, septic tanks, pools, sports courts, utility lines, sewer lines, new landscaping, etc. The Department may require that said plans be prepared by either a landscape architect, architect or an engineer registered in the State of Florida.

Where may I submit an application for a Natural Forest Community permit?

You can submit your application eletronically through the customer portal at

What fees do I have to pay for a Natural Forest Community permit?

Non-refundable initial fee is required upon permit application submission. Additional fees may be charged prior to permit issuance based on the specifics of the application. A 7.5% surcharge will be added to your total NFC permit fees.

What other permits and/or approvals are needed before I start work?

In addition to NFC permits, work in an NFC may require approval from other County agencies, local municipalities or the federal government. It is the property owner's responsibility to verify whether or not additional permits or approvals are needed. If a Building Permit is required, **NO site clearing work shall occur prior** to the issuance of the Building Permit, either by Miami-Dade County's Building Department for properties located in unincorporated Miami-Dade County, or by the local building official for properties located within municipalities.

How can I find out where the boundaries are for the NFC within my property without applying for a permit?

You may request a formal delineation of the NFC within your property. This delineation will include an environmental assessment of the NFC on-site, a map of the NFC boundaries, a plant list, and the NFC Quantative Scorecard for your property. The cost of the delienation is dependent on the zoning of your property and the size. In order to request a formal delineation, please submit a letter signed by the property owner requesting the NFC within the property to be delineated. What happens if I remove or effectively destroy trees or understory within a Natural Forest Community OR do not comply with the conditions and requirements of my Natural Forest Community permit?

You may be issued a "Notice of Violation" and ordered to stop all land clearing and construction until you have complied with Chapter 24-49. Furthermore, you may be required to pay penalties for each violation and replace Natural Forest Community trees and associated understory plants.
