## Uptown Avenue 7 Community Redevelopment Agency

### CRA Security Pilot Program Application

The Uptown Avenue 7 Community Redevelopment Agency (CRA) has contracted with Kent Security, a national leader in video and live security services, to provide security services for business owners in the CRA.

Kent is a national leader in Analytic "Smart" Camera security systems. Unlike typical video cameras that can only record crimes, Smart Cameras detect motion, sound, heat signatures and other biometrics. They can be programmed to detect a wide range of activities within their field of view.

Smart camera systems are designed to stop a crime, not just record it. Once triggered, they instantly alert a team of remote guards at our Central Command Center and begin transmitting a real-time video feed. The video Guards observe the incident, can talk to, and scare off perpetrators in real time, and notify the property owner and police immediately.

The CRA has developed a pilot program to test the system and provide 24/7 monitored smart camera video security for 4 Small Business locations (business locations with less than 20 employees), and 1 Large Business location (a business location at which more than 20 persons are employed). A Large business location could include a plaza or building in which multiple small businesses are located, but the total persons employed at the single property location is more than 20.

The CRA will pay all expenses for the cameras, installation, and monitoring services for the 5 pilot program properties for 1 year. The system provided through the CRA security pilot program includes 2 cameras per property. However, the 5 pilot program properties will be selected by competitive application. In order to be considered you must:

1. Be the lawful owner of the property at which the security services will be provided;
2. Your business location must be within the CRA boundaries; and
3. You business must complete the application on the next 2 pages.
