Miami-Dade County has also adopted Implementing Order No. 3-38, a copy of which is attached is attached hereto as Exhibit "A" and incorporated herein by reference; and

WHEREAS, Implementing Order No. 3-38 serves as the master procurement guidelines for the County; and

WHEREAS, this Board desires to adopt the Procurement Ordinances and Implementing Order No. 3-38 and to be bound by same; and

WHEREAS, this Board believes that it is in the best interest of the Agency and the residents and businesses within the Redevelopment Area to adopt the Procurement Ordinance and Implementing Order No. 3-38,
