The subject property is located at 11925 SW 72 Street, Miami Dade County, Florida.

The request is to allow the establishment of an industrial use involving the distribution of diffuser oils, aromatic products and diffuser scent machines that will use, handle, and generate hazardous materials on a property served by public water and public sewer and situated within the basic wellfield of the Miami Springs Upper, Miami Springs Lower, Hialeah, and John E. Preston Wellfield Protection Area. The subject property is located at 1815 W Okeechobee Road, Hialeah, Florida.

[7 ELEVEN INC \(2024-EQCB-00069\)](#) - Request for an extension of time for compliance with the requirements of section 24-43.1(4), section 24-43.1(6) and section 24-43.1(7) of the Code of Miami-Dade County, Florida. The request is to allow an existing gas station, automotive repair facility, and convenience store to continue to be served by public water and an onsite sewage treatment and disposal system, although the property is required to connect to an abutting and available public sanitary sewer main. The EQCB has previously granted extensions of time via EQCB Order No. 23-22 and EQCB Order NO. 21-02. The subject property is located at 10345 South Dixie Highway, Pinecrest, Florida.
15. [JOSE MIGUEL GUILLEN AND MARIA AZUCENA TORRES \(2024-EQCB-00077\)](#) - Request an extension of time for compliance with the requirements of section 24-43.4 of the Code of Miami-Dade County, Florida. The request is to allow a single-family residence to remain served by an onsite sewage treatment and disposal system although the construction of an addition places the property within feasible distance to connect to an available public sanitary sewer system. The subject property is located at 785 Little River Drive, Miami-Dade County, Florida.
16. [PAW CARE MIAMI, LLC AND ANGELA PINILLA \(2024-EQCB-00043\)](#) - Request for a variance from the requirements of section 24-43.1(4) and section 24-43.1(6) of the Code of Miami-Dade County, Florida. The request is to allow the establishment of a dog kennel that will use, handle, and store hazardous materials and generate liquid waste other than domestic sewage on a property to be served by an onsite domestic well and an onsite sewage treatment and disposal system.
