9. **F&F REAL ESTATE HOLDINGS, LLC (2025-EQCB-00015)** – Request for a variance from the requirements of section 24-43(5) of the Code of Miami-Dade County, Florida. The request is to allow the establishment of a nonresidential land use, specifically a door and window assembly facility, that will store, use, generate, handle, discharge and dispose of a hazardous material and hazardous waste on a property served by public water and public sanitary sewer and situated within the Northwest Wellfield Protection area. The request is to allow the establishment of a nonresidential land use, specifically a junkyard that will generate a liquid waste other than domestic sewage, on a property that will be served by public water and on-site sewage treatment and disposal system. 12. **CEDECO 41 LLC (2024-EQCB-00075)** – Request for a variance from the requirements of section 24-43(5) of the Code of Miami-Dade County, Florida. The request is to allow the establishment of a nonresidential land use, more specifically a gas station and convenience store that will store, use, generate, handle, discharge and dispose of a hazardous material on a property situated within the Northwest Wellfield Protection Area. The subject property is located at, near, or in the vicinity north of NW 41 Street between NW 112 Avenue and NW 114 Avenue, Doral, Florida.
13. **KEVIN DIAZ AND CHRISTINA DIAZ (2025-EQCB-00018)** - An appeal pursuant to the provisions of Section 24-11 of the Code of Miami-Dade County, Florida, to appeal an action or decision by the Director of the Department of Regulatory and Economic Resources - Division of Environmental Resources Management (DERM).
