New hire enrollment

To enroll in benefits, go to https://informs.miamidade.gov and look for the Benefits Enrollment. For new hires, medical coverage is effective on your date of hire. All other benefits are effective on the first of the month following (or coincident to) 60 days of employment.

When can I make changes?

Once the Open Enrollment period closes, you can add or delete dependents on your health plan only under certain circumstances such as a Qualifying Event (QE). Changes must be reported within 45 days of a QE (60 days to add newborns/adoption or placement for adoption). Submit your Life Event benefits change request on the Employee Self-Service portal at https://informs.miamidade.gov.
