STATEMENT OF PURPOSE

The Miami-Dade County League of Cities was formed in 1953 for the purpose of assisting its members in cultivating and maintaining the most proficient ways of administering government for the general welfare of the inhabitants and residents of the area.

Through publication and circulation of information and technical knowledge, the conducting of conferences and meetings, with the interchange of ideas for problem solving, assistance in securing beneficial legislation and opposing injurious legislation, the League fulfills its goals.

Members include municipalities, the Miami-Dade County School Board and Miami-Dade County.

The League also solicits non-voting Associate Members, who, as such, may participate in League activities, and receive monthly agendas, minutes of meetings and bulletins.
