- Substantial Amendment to Citizen Participation Plan, within the 2013-2017, as extended through fiscal year (FY) 2019, Consolidated Plan. The proposed Substantial Amendment includes eliminating the requirement that the County consult with the Model City Community Advisory Committee (CAC) on matters related to the Consolidated Plan for Community Development Block Grant, Home Investment Partnerships, and Emergency Solutions Grant funding and the Model City Neighborhood Revitalization Strategy Area (NRSA). The County would use the alternative citizen participation process set forth in the amended Citizen Participation Plan in the Model City NRSA and in the West Little River NRSA in the event that the West Little River NRSA is unable to meet the minimum number of members to conduct the business of the West Little River CAC.
- Substantial Amendments to the FY 2007-2019 Action Plans and the corresponding FY 2013-2017, as extended through FY 2019, Consolidated Plan in order to recapture and reallocate \$169,729.08 of Community Development Block Grant (CDBG), and \$346,948.66 of HOME Investment Partnerships Program (HOME) funds, and \$21,966.60 of Emergency Solutions Grant (ESG) funds.
