AN ORDINANCE OF THE CITY OF MIAMI SPRINGS, FLORIDA, AMENDING CHAPTER 150, "ZONING CODE" OF THE CITY'S CODE OF ORDINANCES BY AMENDING SECTION 150-017, "RECREATIONAL VEHICLES," TO PROVIDE COMPREHENSIVE AMENDMENTS RELATED TO PERMITTED PARKING AND STORAGE AREAS, SETBACKS, MAINTENANCE, USE, AND QUANTITY OF RECREATIONAL VEHICLES, WHICH INCLUDE BUT ARE NOT LIMITED TO BOATS, CAMPERS, AND MOTOR COACHES; REPEALING SECTION 91-02, "PARKING OR STORING ON PUBLIC PROPERTY"; AMENDING SECTION 101-01, "SUPPLEMENTAL CODE ENFORCEMENT CITATION SYSTEM" TO AMEND THE SCHEDULE OF CIVIL INFRACTIONS AND OF CIVIL PENALTIES RELATED TO VIOLATIONS PERTAINING TO RECREATIONAL VEHICLES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE
