## NOTICE OF PUBLIC HEARING

The Miami Springs Board of Adjustment will meet on **Monday, November 17, 2025**, in the Adult Community Center, 101 Apache Street, Dining Hall, at **6:00 PM**, at which time the matter(s) set forth below will be heard.

The applicant is requesting approval of a dimensional variance for the property located at 1240 Falcon Avenue (folio 05-3024-017-0770), zoned R-1C Single-Family Residential District. The request is for a reduction of the required rear setback from 25 feet to 15 feet, pursuant to Sec. 150-043 of the City's Zoning Code, in order to construct a one-story addition of approximately 1,471 sq. ft. with a 400 sq. ft. covered patio. Approval of the variance would allow the principal structure to be extended to within 15 feet of the rear property line.





You are invited to attend the meeting(s) in person, or you may express your comments in writing to the Office of the City Clerk no later than noon (12:00 p.m.) on the day of the meeting(s).

The above hearing(s) may be continued or deferred to a new date and time certain without further notice provided the date and time of the continuance or deferral is announced at the hearing(s). All interested parties will be heard.
