Summary of Request

The Applicant requests a variance from the front yard setback requirements of Sec. 150-041 (D) of the City Code in order to allow construction of an attached covered aluminum carport structure at the property located at 381 Deer Run within the R-1A Single-Family Residential District.

Based on the materials submitted, the proposed carport measures approximately twenty-four (24) feet by seventeen feet seven inches (17'-7"), containing approximately 422 square feet. The proposed structure would be attached to the principal residence and located approximately eight feet (8') from the front property line. Accordingly, the request seeks relief from the required thirty (30) foot front yard setback established by Sec. 150-041 (D) of the City Code.
