I. Welcome/ Introductions

Chairman Darryl Holsendolph called the Goods and Services Advisory Board meeting to order at 10:45 a.m. Mr. Dwayne Holloway (SBD) conducted the roll call with four (4) advisory board members present. The Office of Small Business Development (SBD) introduced themselves.

II. Old Business

Approval of both January 16, 2025, and February 25, 2025, Meeting Minutes

Ms. Maria Molina moved to approve the minutes, and it was seconded by Mr. Junior Silva. The motion passed by a vote of 4-0.

III. Discussion

Chairman Daryl Holsendolph announced there were significant changes within Miami Dade County and the Office of Small Business Development.

Ms. Laurie Johnson (SBD Interim Director) acknowledged the recent transition of former SBD Director, Mr. Hartfield, to Miami Dade Aviation Department. Ms. Johnson informed the board that, pending approval from the Board of County Commissioners', the Office of Small Business Development would officially merge with the Strategic Procurement Department (SPD). She assured that all Small Business Advisory Boards and Programs will continue and share that effective July 1st, licenses for many trade areas will no longer be required under Florida Statue. She noted that SBD was actively working with the County Attorney's office to identify trade areas that could transition into service categories to expand the opportunities for certified small businesses.

Chairman Holsendolph stated that the removal of licensing allows small businesses to conduct the work, while certifications of minority-owned Small Businesses would go away. He voiced skepticism about the SBD and Procurement merger's benefit and questioned how Miami Dade County ensure meaningful participation from local small local businesses.

Mr. Junior Silva cited a recent \$600 million no-bid construction contract at Miami International Airport awarded to two local companies. He stated that when he offered his SBE certification and food services, he was dismissed, emphasizing that without enforcement of requirements, small businesses will struggle to survive..

Ms. Maria Molina congratulated Ms. Laurie Johnson on her interim appointment and stressed the importance of small business advocacy. She recognized Chairman Holsendolph's community leadership and encouraged him to continue his efforts.

Ms. Makeba Gassant commended Ms. Johnson for her leadership and commitment to small businesses. She acknowledged state-level changes but advocated for local tax dollars to stay within the community through legislation requiring local business participation on major contracts. She emphasized the Board's continued need for Mr. Holsendolph's leadership while recognizing the importance of his health.

Chairman Holsendolph noted that with the loss of construction opportunities, the goods and services sector may be next.. He asked Ms. Johnson how were firms supported through the certification process and what was the certification worth Mr. Holsendolph expressed concerns about the direction of the Office of Small Business Development merging with procurement.

Ms. Johnson stated that the Office of Small Business Development (SBD), Strategic Procurement Department (SPD), and the user department would collaborate on documentation. She clarified that not all construction projects were suitable for small business participation, but all projects from County departments go through SBD review. Ms. Johnson noted that historically, SBD's focus was on trades due to program requirements.

Mr. Holsendolph reiterated the importance of expanding into the services sector and questioned the future utilization of licensing, given federal efforts to reinvest in trades.

Ms. Johnson clarified that SBD could only apply goods and services measures not tied to construction trades. She noted SBD’s efforts to unbundle projects and ensure SBEs have the financial and bonding capacity to secure materials.

Makeba Gassant expressed concern over the burden of recertification and asked whether the certification process could be streamlined for service vendors.

Ms. Johnson acknowledged the concern and stated that the Board had been emailed the current certification language for feedback. She proposed scheduling a virtual meeting to further address the certification process.

Mr. Junior Silva requested clear direction and a timeline for next steps post-merger and the updated mission statement.

Ms. Johnson informed the board that the merger is set for Board approval on May 20th. Once the media budget supporting the merger is approved, the mission statement will be developed. She affirmed the mayor’s commitment to supporting small businesses and the local economy.

Makeba Gassant mentioned that prior discussions on using local business tax mailers to raise awareness, expressing concern that this initiative has been lost in the procurement budget.

Chairman Holsendolph expressed concern over SBD’s ability to advocate, market, and communicate post-merger.

Ms. Johnson assured the Board that within 90 days, more clarity would emerge. She noted that SBD’s mission to advocate for small and local businesses would remain unchanged.

Ms. Lawanda Wright introduced Katia Moyer, a newly hired marketing team member focused on communications via social media and radio. She confirmed that mailers will be distributed with the Local Business Tax notices by mid-summer.

Chairman Holsendolph mentioned the Board’s prior recommendations to engage user departments, stating that current uncertainty has stalled these efforts.

IV. Report – Jackson Health System

Ms. Amber Lawhorne summarized the report for the period of February 1, 2025 – March 31, 2025. She highlighted the total spend (\$132,721,131), the inaccessible spend (\$130,119,062), and the accessible spend (\$2,602,069) for the period. She

stated that the SBE Spend was \$817,398 and the percentage of SBE spend was 31.41%. She stated JHS reported 7.6 4% of accessible spend in the last period.

Makeba Gassant asked for clarity on what constitutes as implementing bid waivers and how were they issued.

Mr. Juan Jaramillo explained that bid waivers are used when internal assessments find insufficient capacity for competition. In such cases, waivers may be considered to meet service demands.

Makeba Gassant asked whether JHS could partner with SBEs for non-medical furniture procurement and suggested broader outreach to identify business opportunities.

Mr. Juan Jaramillo affirmed JHS's commitment to outreach through calls, emails, and clarifications to help SBEs participate. He emphasized continued efforts via newsletters, webinars, and the supplier portal.

Mr. Holsendolph recommended that JHS revise future reports to reflect the Percentage of Available Spend rather than total spend. .

Ms. Amber Lawhorn confirmed that JHS report will reflect the Percentage of the Available Spend in reports moving forward.

Mr. Juan Jaramillo recognized Amber Lawhorn and her team, Romelia Brown and Miranda Laguna. He stated that JHS is proud of the partnership that the procurement management team and the SBE Team have built for close to 17 years.

Mr. Junior Silva informed the board of upcoming travel commitments and expressed willingness to attend meetings via Zoom.

Ms. Michou Jean confirmed that remote attendance was permitted, but voting was not allowed under state guidelines. She added that SBD has notified all district offices of current board vacancies and encouraged board members to refer interested candidates.

Ms. Lawanda Wright reported that Federal International Football Association (FIFA) conducted a presentation during Small Business Week. She noted SBD would be working with the World Cup 2026 host committee, which has committed to a supply program. Ms. Wright stated SBD was actively distributing lists of SBEs with relevant

industry codes and will hold community meetings to strategize local business participation in the 33-day event.

Mr. Jason Smith stated that SPD was reviewing board requests from previous meetings. He affirmed SPD's commitment to quality control and departmental review before issuing formal reports.

Chairman Holsendolph raised concerns regarding the inclusion of local small businesses in legacy system upgrades and emphasized the importance of incorporating local technical firms into future contracts. .

Ms. Michou Jean asked whether they would like to hold a special meeting on streamlining the certification process.

Chairman Holsendolph confirmed that a special meeting will work best for the board to focus and give insight on streamlining the certification process.

V. SBD Section Reports

Business Outreach & Education – *Report deferred to the next Goods and Services advisory board meeting.*

Certification – *Report deferred to the next Goods and Services advisory board meeting.*

Utilization – Patrick Hines (SBD) presented the utilization report for the period of February 1, 2025 – March 31, 2025. Mr. Hines informed the board of the total amount of contracts awarded (101,421,733) and contracts paid (151,041,936). Mr. Hines explained the demographics displayed on the chart for contracts awarded and paid.

Makeba Gassant stated that traditionally, the report had included percentage data, and the board would prefer to maintain that format. She emphasized the importance of tracking the percentage of total contract dollars awarded versus the amount paid to SBEs, as this metric was essential for monitoring trends and assessing progress.

Chairman Holsendolph questioned the inclusion of purchase orders (P.O.s) in the report, noting that the report was intended to reflect actual expenditures rather than purchase orders.

Alicia Anderson clarified that the system identifies contract awards under the broader contract as purchase orders, which is why a P.O. breakdown appears in the report. She explained that the data represents actual awards, and the amounts paid.

Ms. Anderson further confirmed that the system classifies these transactions as P.O.s, and that designation is generated upon entry into the system.

Ms. Laurie Johnson emphasized the importance of ensuring clarity in the utilization report, as purchase orders often fall under pre-qualification pools. She explained that goods and services expenditures were separate and not included under pre-qualification pools. Ms. Johnson reiterated that SBD will seek further clarification regarding the origin and classification of purchase orders, whether they were linked to pre-qualification pools, and whether goods and services expenditures are for standalone projects.

Ms. Makeba Gassant requested information on whether the utilization report accounts for (Purchase Card) P-Card spending. .

Mr. Holsendolph inquired whether P-Card expenditures fall under any utilization criteria and whether they should be directed toward small businesses. He also questioned who the recipients of P-Card spending were.

Ms. Johnson responded that, to her knowledge, P-Card expenditures were not currently captured in the system. However, she committed to following up with the Information Technology Department to obtain clarification and report back.

VI. New Business

Makeba Gassant suggested that the Small Business Development Division (SBD) consider strategies to retain tax dollars within the local economy. She recommended exempting locally certified small businesses from the fees associated with the User Access Program (UAP) and the National Institute of Governmental Purchasing (NIGP).

Chairman Holsendolph supported the idea but proposed narrowing the exemption by establishing a cap or tiered limit to align the initiative with existing policies and to ensure boundaries are defined.

Mr. Junior Silva expressed his support for the recommendation, stating that the 2.25% fee places small businesses at a competitive disadvantage. He explained that while large corporations can absorb the fee, small businesses must incorporate it into their pricing, making their proposals less competitive. .

Ms. Johnson responded that implementing such a change would require legislative amendments, as both UAP and NIGP fees are contractual and not limited to small businesses. She noted that SBD does not govern this legislation, which falls under the purview of Strategic Procurement. However, SBD will engage in discussions with

the Director of Strategic Procurement to assess the feasibility of pursuing this recommendation. Ms. Johnson emphasized that SBD would continue operating under current guidelines and will review all task force recommendations that affect procurement processes. She recommended that the proposal be added to the Task Log for further evaluation and formal response.

Mr. Jason Smith invited board members to participate in a series of budget conversations hosted by County Mayor Daniella Levine Cava. The scheduled events are as follows:

- Friday, May 16th from 6:00 p.m. to 8:00 p.m. at the Main Library Downtown, 101 West Flagler Street.
- Saturday, May 17th at 12:30 p.m. at the North Dade Regional Library, 2455 NW 183rd Street, Miami Gardens.
- Monday, May 19th at the South Dade Regional Library (time not specified).

Chairman Holsendolph asked whether a document outlining the mayor's budget priorities was available.

Mr. Jason Smith confirmed that, per County Code, the Mayor is required to release a budget message. He stated that the message has already been distributed to both the Board of County Commissioners and the community. Mr. Smith committed to providing a copy of the budget message to the Office of Small Business Development's administrative assistant for distribution to board members. He also agreed to send the event flyer along with the Mayor's budget message, which serves as the preface to the upcoming discussions.

VII. Reasonable opportunity for the public to be heard before the County Boards (Sec. 2-11.39.3)

Chairman Holsendolph opened the reasonable opportunity for the public to be heard; seeing no one speak, the reasonable opportunity to be heard was closed.

VIII. Adjournment

There being no further business to come before the SBE-Goods and Services Board, the meeting was adjourned at 12:22 p.m.
