#### **Welcome/Introductions**

Chairman Juan A. Crespi called the Architecture and Engineering (A&E) Advisory Board meeting to order at 10:39 AM. Sandra Petithomme conducted the roll call of the Advisory Board members & SBD staff introduced themselves.

#### **Old Business**

#### Approval of September 25, 2024 - Meeting Minutes

Ms. Maria Luisa Castellanos stated that the minutes did not reflect Mr. Crespi's comment on the lack of architecture projects and neither did it mention the board's discussion about inviting different county departments to the Architecture and Engineering (A&E) Advisory Board meetings.

It was moved by Ms. Ivette Argudin to add Mr. Crespi's comment on the lack of architecture projects and inviting different county departments to the Architecture and Engineering (A&E) Advisory Board meetings to the September 27, 2024, minutes. This motion was seconded by Ms. Berrin Tansel. The motion passed by a vote of 5-0.

#### **SBD Section Reports**

**Business Outreach & Education – Carlos Ansuarez (SBD Section Manager)** presented the report for the period of August 1, 2024 – September 30, 2024. Mr. Ansuarez informed the board that there was a total of sixty-three (63) for Certification Assistance; two (2) Needs Assessment; zero (0) Payment Issue; Payment Issues Related to Dollars equaled \$23,295 Year-to-Date; One thousand two hundred eighty-nine (1,289) Contacts with SBE A&E Firms for contract opportunities.

Certification – Jeanise Cummings (Section Chief) presented the report for the period of August 1, 2024 – September 30, 2024. She informed the board that there were 234 certified

SBE firms; one (1) New Applicant; three (3) recertification applications; no firms graduated,

and none denied.

In response to Mr. Moss's inquiry regarding the number of firms that were certified as architecture, Ms. Cummings explained that the report was structured based on the program and it identified whether the firm was certified under the architect and engineering category. She also stated that it does not distinguish between architecture from engineering.

Chairman Crespi reiterated that the certification report provided an account of participants and cannot differentiate between architecture and engineering firms because many firms hold multiple certifications.

**Utilization – Patrick Hines (SBD)** presented the report for the period of August 1, 2024 – September 30, 2024. Mr. Hines reported the total number of contracts awarded, including the demographics, during the period was \$26.1 million and the total number of contracts paid was 23.9 million.

Ms. Michou Jean presented the newly added charts and graphs, initiated by Section Chief Obed Jiron, which simplifies the utilization report data.

Ms. Ivette Argudin questioned how the Professional Service Agreement (PSA) would be advertised. Mr. Pablo Valin from the Strategic Procurement Department (SPD) stated that a (PSA) would be the contract that gets awarded following an advertisement process, as well as contracts awarded through the Equitable Distribution Program.

Ms. Castellanos questioned which contracts were being categorized as Design Build and which departments were utilizing Design Build contracts. Mr. Valin explained that departments could issue the contracts for both the design and construction phases or follow a traditional design -bid -bill process.

Chairman Crespi recommended not including a Design Build report within the current utilization reports, but as a separate report.

It was moved by Ms. Maria Luisa Castellanos that the A&E advisory board receive a report on the design build as a separate report detailing design build contracts and including information of their usage and which departments were using this type of contract. Mr. Moss seconded the motion, and the motion passed by a vote of 5-0.

#### November 13, 2024, Meeting Minutes

Mr. Patrick Hines stated the data team could generate a report specifically on design build contracts, identifying the departments involved.

Mr. Obed Jiron inquired about the timeline for the requested report. Chairman Crespi suggested including data from the last three to five years and indicating the A&E Goal and the amount paid for the project.

Chairman Crespi also requested a report on the number of A&E firms interviewed for jobs and how many were awarded contracts.

Ms. Ivette Argudin requested that staff monitor and report on the number of architectural firms serving as prime on Equitable Distribution Program contracts. Additionally, Ms. Argudin sought clarification on on the correct procedure for reporting payment discrepancies in Business Management Workforce System (BMWS

Ms. Alicia Anderson explained the proper reporting procedures for addressing errors via the BMWS.

#### Report - Jackson Health System (JHS)

**Kenneth Robertson** presented the report for the period of August 1, 2024 – September 30, 2024, noting six (6) of twelve (12) awards for the period were to SBE Primes, with an overall participation of 40.09%. Running Year-To-Date thirty-three (33) of fifty-six (56) projects were awarded to SBE Primes, with an overall participation of 57.24%.

Mr. Robertson indicated that (JHS) was preparing a Request for Qualifications (RFQ) for a window retrofit improvement at the Jackson South Medical Center, which was expected to be released within the next two (2) weeks. He noted this an informal (RFQ) would involve an A&E fee just under \$250,000. Mr. Robertson stated that early next year (JHS) plans to readvertise its continuing term contracts, which currently were designated SBE set asides.

Ms. Castellanos questioned whether (JHS) required firms to hold specific certifications. Mr. Robertson explained that (JHS) assessed qualifications through the county's prequalification and technical certification process.

Chairman Crespi inquired whether certification from the Agency for Health Care Administration (AHCA) was included in the evaluation criteria. Mr. Robertson stated that he was not aware of any certification issued by AHCA to firms but explained that (JHS) prefers firms with completed projects that have undergone AHCA review and approval.

Ms. Castellanos questioned whether AHCA experience was necessary for window replacement projects. Mr. Robertson responded that requirements vary depending on the project's location and the scope of work.

#### **Advisory Board 2025 Meeting Dates**

It was moved by Mr. Brett Moss that the November 26 meeting date be changed to November 19, 2025. Ms. Berrin Tansel seconded the motion, and the motion passed by a vote of 5-0.

#### **New Business**

#### **Board Questions for Departments**

Ms. Maria Luisa Castellanos presented a list of questions she had prepared for department representatives attending the board meetings. The board decided to remove questions 5 and 10 from the list of questions.

#### **Architecture & Engineering Advisory Board**

**Questions for County Departments** 

- 1. What qualifications or relative experience should a firm have to be selected?
- 2. How many projects did your department put out through the Equitable Distribution Program through set asides and through RFP for 2024?
- 3. How does your department decide which projects go through the Equitable Distribution Program, the RFP, and which are set aside?
- 4. Give a list of Projects put out by your department, which method of procurement was used and what firms were selected in 2024?
- 5. How many Small Business Enterprises were awarded contracts by your department?
- 6. What was the 2024 budget for architecture projects?
- 7. What was the 2024 budget for engineering projects?
- 8. What upcoming architecture projects does your department have?
- 9. What upcoming engineering projects does your department have?

Mr. Brett Moss proposed adding a question regarding the qualifications or relevant experience firms should possess to be considered for selection.

Mr. Pablo Valin (SPD) clarified that all county departments, except for Jackson (JHS) and the School Board, procurement for A&E were above the Equitable Distribution Program threshold, which was centralized through strategic procurement. He added that one hundred forty (140) firms were certified by the county to provide architectural services, of which fifty-six (56) to (40%) were Small Business Enterprise (SBE) certified firms.

Ms. Castellanos suggested the board invite Public Housing and Community Development (PHCD) to the board meeting.

Mr. Robertson (JHS) explained that PHCD utilizes a Public-Private Partnership (P3) Model for developer agreements, where the developer was responsible for funding all improvements.

He also noted the Architecture & Engineer (A&E) Design Bid Build work was included within the developer's scope.

Mr. Brett Moss suggested inviting representatives from Aviation and Seaport departments to the next A&E board meeting.

The board has agreed to invite a representative from Seaport department and schedule twenty minutes on the agenda for questions and answers session.

#### **Welcome/Introductions**

Chairman Juan A. Crespi called the Architecture and Engineering (A&E) Advisory Board meeting to order at 10:41 AM. Dwayne T. Holloway conducted the roll call of the Advisory Board members & SBD staff introduced themselves.

#### **Old Business**

#### **Approval of November 13, 2024 - Meeting Minutes**

Ms. Maria Luisa Castellanos stated that the minutes did not reflect the list of questions the advisory board agreed to ask the visiting county departments. Ms. Castellanos requested the questions for the county departments be added to the minutes of the last meeting. Mr. Brett Moss pointed out a redundancy of his statement on page four in the third paragraph. Mr. Pablo Valin stated that on page four, the third paragraph from the bottom, has a sentence that should read "Design Bid Build" instead of Design. Ms. Castellanos clarified that she only wanted to add the questions the board wanted answered by the visiting departments, not the questions that were removed.

#### **Discussion**

Seaport Department - Ms. Ivonne Andres (Manager, Construction Contract) and Mr. Brad Skinner, Construction & Procurement

Chairman Crespi informed Ms. Andres and Mr. Skinner that the board requested a Seaport Department representative to be provide clarification on Small Business participation in current and upcoming projects, as well as direct opportunities through set-asides. He also conveyed to the Seaport representatives that the Jackson Health Systems report served as an example of what the board was seeking.

Ms. Ivonne Andres informed the board that she was prepared to present an overview of the Seaports ongoing Equitable Distribution Project's (EDP), Professional Service Agreement's (PSA), and future initiatives. She stated that Seaport has EDP's and PSA's totaling to \$72 million in ongoing projects, with an additional \$42 million in upcoming projects. She provided a detailed a breakdown, highlighting over 40 ongoing EDP's, 16 active PSA's, and 12 upcoming PSA solicitations. Ms. Andres also emphasized that Seaport collaborated closely with the Office of Small Business Development to establish Small Business Enterprise Architecture & Engineer (A&E) goals for each project and with coordinated efforts with A&E board members downtown.

**Chairman Crespi** explained to the Seaport representatives that SBD analyzes all county projects and could determine the participation of engineering and architecture. He pointed out stated that reports indicate little to no architectural participation. Mr. Crespi emphasized that the board would like the Seaport Department to increase architectural involvement in projects.

**Mr. Skinner** informed the board that when preparing a project, the Seaport Department reviews the scope and collaborate with SBD based on technical certifications, to determine Small Business Goals and utilizations. He then asked the board for recommendations on how the Seaport Department could increase architectural participation.

**Chairman Crespi** replied that the way a project is described could either enable or prevent architectural participation. He stressed the importance of deliberately wording project descriptions to ensure they do not exclude SBE Architectural firms' participation. He acknowledged that larger projects were often architecture-driven at the prime level and suggested that 10% should be allocated to an SBE firm. Chairman Crespi also stated that SBE A&E firms were unable to participate in Design-Build projects unless specific criteria were established to include them.

**Ms. Castellanos** suggested that the Seaport Department could structure advertisements to explicitly seek Small Businesses in architecture and firms that utilize external engineering consultants. She emphasized that the board wants these advertisements to be crafted in a way that encouraged small business participation.

**Chairman Crespi** pointed out that treating small business participation as just a number was part of the issue. . He reiterated the existing gap in architectural participation , and stated that the board was requesting a mandatory 5-10% participation in this category.

**Mr. Skinner** acknowledged the board's concerns but noted that the Seaport Department must operate within the confines of policy. He emphasized that the projects in these solicitations were substantial in scale and suggested implementing a Small Business Development Program to educate firms on how to work with county departments with large projects.

**Ms. Castellanos** clarified that being categorized as a Small Business does not mean a firm was to the industry. She emphasized that as an experienced architect, analytical skills determine how well you work through a project and develop solutions. She further stated that the A&E Board was advocating for meaningful project opportunities, whether through Set-A sides or EDP.

**Mr. Pablo Valin (SPD)** explained that when Strategic Procurement received a solicitation, they review the scope of work and technical categories involved. He agreed that most projects from the Port of Miami (Seaport) were large projects. Mr. Valin stated that there were two primary ways to structure solicitations for SBE's: through the EDP and Set-Asides. He recommended that the Seaport Department consider Set-Asides for SBE architectural firms when port facilities require renovations.

**Ms. Michou Jean** provided an overview of the questions and discussion topics that the board had agreed to send to the Seaport Department prior to the upcoming A&E meeting.

- This year's budget for architecture projects
- The criteria for determining which projects go through the EDP process
- Upcoming architecture and engineering initiatives

**Ms. Castellanos** mentioned that the board had agreed to send all their questions to the Seaport Department prior to the meeting. **Ms. Jean** clarified that the board had only agreed to send the three questions from the list.

**Chairman Crespi** recommended that the Seaport Department representatives submit a bimonthly report in comparison to the Jackson Health System report.

Mr. Brett Moss suggested sending the entire list of questions to Seaport.

**Mr. Skinner** supported the idea that the questions be sent to Seaport Chief Frank Ramirez, Ms. Andres, and himself.

#### January 29, 2025, Meeting Minutes

**Ms. Jean** asked the board members which department would they like to invite to the next meeting. The board decided to invite a representative(s) from the Aviation Department and agreed to send the full list of questions to all visiting county departments before the meeting.

#### Report - Jackson Health System

**Kenneth Robertson** presented the report for the period of October 1, 2024 – November 30, 2024, noting seven (7) projects were awarded for the period totaling \$200, 694.39. Five (5) of the seven (7) were to SBE Primes, with an overall participation of 93.98% totaling \$188, 612.91. Running Year-To-Date thirty-eight (38) of sixty-three (63) projects were awarded to SBE Primes, with an overall participation of 59.72%.

Chairman Crespi questioned if the upcoming project was a continuous contract. Mr. Robertson confirmed that Jackson Health System (JHS) had several solicitations in progress and was currently evaluating proposals for the Federal Emergency Management Agency (FEMA)-funded Jackson South window and door retrofit project. He also mentioned that JHS had one renewal year remaining on the continuing services Set A-Side contracts, which would be advertised this year to on-board additional firms. Additionally, Mr. Robertson mentioned that JHS had ongoing EDP requests for more architectural firms to work on current projects, which were in the interview stage.

**Mr. Brett Moss** questioned whether the window and door solicitation was specifically for an architectural firm. Mr. Robertson confirmed that it was for Architectural & Engineering services, with technical certifications included as subprime for various product evaluation services.

**Mr. Raul Velarde** questioned whether the repetition of firm names was related to the continuing services agreement. Mr. Robertson acknowledged the SBE architectural firms serving as prime contractors with Jackson and confirmed the Set A-Side solicitation for structural engineering services had been awarded to an SBE firm.

#### **SBD Section Reports**

**Business Outreach & Education – Carlos Ansuarez (SBD Section Manager)** presented the report for the period of October 1, 2024 – November 30, 2024. Mr. Ansuarez informed the board that there was a total of fifty-six (56) for Certification Assistance; five (5) Needs Assessment; one (1) Payment Issue; Payment Issues Related to Dollars equaled \$73,295 Year-to-Date; One thousand fourteen (1,014) Contacts with SBE A&E Firms for contract opportunities.

#### **January 29, 2025, Meeting Minutes**

**Chairman Crespi** stated the payment issues remain prevalent with agencies delaying payments to prime contractors, which in turn affects subcontractors. However, he noted many firms were reluctant to file complaints.

**Ms. Yvette Argudin** questioned whether feedback from the Business Management Workforce System (BMWS) regarding SBE payments was being reviewed. In response, **Mr. Carlos Ansuarez** clarified that the SBD Business Outreach & Education (BOE) team intervened only when a firm reports a payment issue.

**Ms. Alicia Anderson** (SBD Section Manager) outlined the payment process, explaining that BMWS contains a section dedicated to payment issues. She emphasized that responses in this section are visible only to SBD and that the system automatically alerts the contract compliance unit if a firm disputes a payment.

**Certification – Jeanise Cummings (Section Chief)** presented the report for the period of October 1, 2024 – November 30, 2024. She informed the board that there were 230 certified SBE firms; zero (0) New Applicant; two (2) recertification applications; no firms graduated, and none denied.

**Utilization – Patrick Hines (SBD)** presented the report for the period of October 1, 2024 – November 30, 2024. Mr. Hines reported the total number of contracts awarded, including the demographics, during the period was 6.8 million and the total number of contracts paid was 70.1 million.

Ms. Laurie Johnson (SBD Section Chief), clarified that the payment and award data in the Utilization report originated from the INFORMS system, which displays certain projects as PSA when they were actually architectural or engineering projects. She acknowledged the discrepancy and assured the board that the report would be edited to properly identify these projects.

Ms. Castellanos inquired whether the information would be reported by the next board meeting.

**Ms. Johnson** stated that the SBD staff would make every effort to ensure the updated information is reflected in the utilization report.

#### Task Log

Laurie Johnson (SBD Section Chief) addressed the board's request for an Equitable Distribution Project (EDP) report that distinguished architects and engineers serving as prime contractors. She provided the board with a printout displaying SBD's current

dashboard to illustrate how the system generates reports. She explained that the report outlines how EDP assignments are issued, categorizing them as Design, Planning, or Study projects. She stated due to systems current configuration, SBD was unable to generate a report identifies the technical categories or specifies whether the prime contractors on EDP projects were architectural or engineers. She informed the board that SBD was collaborating with the Information Technology Department (ITD) to rewrite the Capital Improvement Information System (CIIS), which manages the EDP process, to enhance reporting capabilities.

**Ms. Yvette Argudin** requested clarification on the county department acronyms listed in the dashboard printout. In response, Ms. Johnson stated if the board wished, this printout could be provided on a bi-monthly basis.

Ms. Johnson also acknowledged that in Design Build projects, architect or engineers were typically not the prime contractors. She stated that SBD could develop a separate, project specific report focusing solely on Design Build projects.

**Mr. Raul Velarde** expressed interest in a Design Build report, noting that the current Utilization report shows zero for architecture.

**Ms. Johnson** clarified that the Utilization report was strictly focused on the finance. She explained that if the board wanted a breakdown of teams for Design Build or Design projects, it would need to be presented on a project-specific basis rather than as part of the utilization data.


#### **New Business**

**Ms. Laurie Johnson (SBD Section Chief)** informed the board that SBD is in the process of streamlining the certification process. She acknowledged that the firm must have a local location where site visits could be conducted, firms must submit tax documents, personal net worth, the owner must have at least 25% ownership to qualify for certification.

Ms. Johnson informed the board that SBD staff would send board members a copy of the current certification process for review and discuss during the next board meeting.

Questions for County Departments

- 1. What qualifications or relative experience should a firm have to be selected?
  - a. Qualifications and experience are based on the scope of services being requested. See some examples below:
    - Terminals and Ropax Facilities Prime Consultants must have five (5) years of experience for similar work as described in the scope of services denoted above. The expertise must be met by a qualified individual(s) of the prime firm. The experience must be demonstrated by direct or substantial involvement of the individual(s) in a supervisory capacity at the Project Manager level or above.
    - ii. Professional Services Agreements for Civil Infrastructure Engineering Services The Prime Consultant must demonstrate experience in five (5) projects performed in the State of Florida over the past ten (10) years of similar work as described above. The expertise must be met by a qualified individual(s) of the prime firm. The experience must be demonstrated by direct or substantial involvement of the individual(s) in a supervisory capacity at the Project Manager level or above.
    - iii. Planning Consultant Services The consultant(s) proposing on this solicitation are preferred to have extensive relevant deep-water seaport experience, with three (3) comparable deepwater seaport master planning projects, inclusive of the planning and design of cruise, cargo, and other maritime programs in ports as impacted by the current and future market demands being served. Experience in one inland port planning and/or development is preferred. The above expertise must be met by qualified individuals of the prime consultant's and/or subconsultant's firm.
