RESOLUTION NO.

RESOLUTION REQUIRING ALL MEMBERS OF COUNTY ADVISORY BOARDS TO COMPLETE A MANDATORY SEXUAL HARASSMENT TRAINING AS A CONDITION OF MEMBERSHIP, AND DIRECTING THE CLERK OF THE BOARD TO PROVIDE A QUARTERLY REPORT TO THE BOARD STATING THE NAMES OF THOSE BOARD APPOINTEES WHO HAVE FAILED TO COMPLETE THE SEXUAL HARASSMENT TRAINING COURSE

WHEREAS, it is the policy of Miami-Dade County that sexual harassment is a form of discrimination that is not to be tolerated within the workplace; and

WHEREAS, County, state, and federal laws prohibit sexual harassment in the workplace;

and

WHEREAS, this Board believes that sexual harassment or misconduct of any kind has no

place in state government; and

WHEREAS, this Board is committed to providing a working environment for all County advisory boards, as that term is defined in section 2-11.36.1(a) of the Code of Miami-Dade County, that is free from sexual harassment for all members of advisory boards, and for those who interact with advisory boards; and

WHEREAS, the Miami-Dade County Office of Human Rights and Fair Employment Practices ("OHRFEP") has developed countywide training courses on unlawful harassment geared towards, among other things, making sure the workforce understands organizational rules, policies, procedures, expectations, and consequences of misconduct; and

WHEREAS, this Board believes that it is in the best interest of the County to require members of all County boards to complete a mandatory sexual harassment training as a condition of membership,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board directs that the members of all County advisory boards, as that term is defined in Miami-Dade Code section 2-11.36.1(a) of the Code of Miami-Dade County, shall be required to complete a mandatory sexual harassment training course to be developed by the County Mayor or County Mayor's designee, such as the Miami-Dade County Office of Human Rights and Fair Employment Practices. All current and future board members shall be required to complete the mandatory sexual harassment training course pursuant to a schedule developed by the County Mayor or County Mayor's designee.

Section 2. This Board directs the Clerk of the Board to submit a quarterly report to this Board stating the names of those board appointees who have failed to complete the mandatory sexual harassment training course, and to place the completed report on an agenda of this Board pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Vice Chairwoman Audrey M. Edmonson and the Co-Sponsors are Commissioner Daniella Levine Cava and Commissioner Rebeca Sosa. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:
