I. Welcome/Introductions:

i. Chairman Juan Crespi called the Architecture and Engineering (A&E) Advisory Board meeting to order at 10:40 AM. Advisory Board members, SBD staff, and online participants introduced themselves.

II. SBD Section Reports (20 min)

a. SBE-A&E Certification Report – Jeanise Cummings-Labossiere (SBD Section Chief)

Jeanise Cummings-Labossiere (SBD Section Chief) presented the report for Certification. Chairman Crespi requested for the Certification section to condense the Ethnicity & Gender Summary into one sheet. He would also like the Race and Genderneutral statement to be larger be on the document.

b. SBE-A&E Utilization Report-Rossi Siewnarine SBD (SBD Section Chief)

Rossi Siewnarine notified the board that the report for the period of May 1, 2021 – July 1, 2021, is not available. He stated that in April, Miami-Dade County implemented their Enterprise Resource Planning (ERP) Solution to transform the County's business processes. It was given the system name of "INFORMS" which stands for Integrated Financial Resources Management System. As a result of the implementation, SBD has recognized that certain data is not carrying over to Business Management Workforce System (BMWS). Staff is in process of working with the necessary departments and organizations to resolve this issue.

c. SBE-A&E Business Outreach and Education Report - Lawanda Wright-Robinson (SBD Section Chief)

Lawanda Wright-Robinson presented the report for the period May 1, 2021, to June 30, 2021. There were no questions regarding the report.

b. Update on MDC Professional Services Task Force recommendations

Debbie Swain provided an update regarding the status of the Miami Dade County Professional Task Force Recommendation. The proposed recommendation allowed locally headquartered businesses to be eligible to participate in the Equitable Distribution Program (EDP). Small business Development would like the recommendation to include all SBE firms, not only locally headquartered firms. Gary T. Hartfield (SBD Director) began by explaining that Small Business Development will always advocate for Small Business Enterprise Firms. Mr. Hartfield explained that he believes Locally Headquartered firms, as well as SBE's, should be in the EDP. He explained that the purpose of Small Business Development is to advocate for Small Businesses.

Chairman Crespi stated that the only point that a locally headquartered business can compete is in the EDP. Ms. Johnson inquired if the request of the Task Force is to only include locally head quartered firms regardless of if they are an SBE or not in the EDP, Debbie Swain confirmed yes, that is the request. Ms. Johnson advised that the Advisory Board and Task Force previously recommended to include both SBE's and Locally Headquartered firms in the EDP and now the request is changing.

Chairman Crespi stated that his concern is that National firms will come in and continue to take top projects. Mr. Hartfield requested clarity, he asked Ms. Swain if their request is to make a subset of A&E SBE firms of only those who are locally headquartered to be allowed to be in the EDP. Ms. Swain confirmed that this is their request and Mr. Hartfield advised that he must speak with the Attorney to see if he could make a subset of the SBE firms being that in the SBE program, being locally headquartered is not required. Ms. Johnson advised that the EDP Program is governed by 3-39 not 3-32. A conversation must be held with attorneys to see what is possible.

Pablo Valin advised the Advisory Board that County Attorney Miguel Gonzalez is reviewing 3-39 regarding the EDP. He advised the attorney still has time to make changes before it goes to the Board.
