## RECOMMENDATION

Department of Transportation and Public Works (DTPW) Capital Improvements staff completed the review of Design/Build Services project 20220112 in accordance with the applicable provisions of Implementing Order 3-22 and requested the review and approval from Small Business Division (SBD). Attached is the Project Measure Analysis and Recommendation along with other supporting documentation.

Scope of Work:

The PD&E Studies have the following project objectives:

- The CONSULTANT is to study the major rehabilitation and/or replacement of the existing Bear Cut Bridge (Bridge No. 874544) and other bridges along the Rickenbacker Causeway as necessary. The CONSULTANT must evaluate other feasible alternatives, which will include refinements, if applicable. However, since the goal is the rehabilitation and/or replacement of the existing bridges, the CONSULTANT will study improvements along the existing corridor.
- The CONSULTANT will analyze and assess the Project's impacts on the social, economic, cultural, natural, and physical environment, in order to develop the Location and Design Concept of the Project in accordance with FDOT policy, procedures, and requirements.
- The CONSULTANT shall review and become familiar with Project documents and materials that have been prepared prior to the PD&E phase. The CONSULTANT will review the Efficient Transportation Decision Making Process (ETDM) Programming Screen Summary Report,

including comments received from the Environmental Technical Advisory Team (ETAT), Lead Agency, and / or any responses from the District pertaining to this Project. The CONSULTANT shall also review concepts and reports (e.g., typical sections, alignments, planning reports) developed from prior planning studies. The CONSULTANT shall use resource agencies' comments to assess the level of effort for work activities required to adequately address potential resources of concern to this Project.

- The anticipated Class of Action (COA) is an Environmental Assessment. However, it is the responsibility of the CONSULTANT to evaluate, analyze, and propose any opportunities to downgrade the COA and accelerate the project.
- The CONSULTANT shall perform the Studies to meet the requirements of the State of Florida and Federal Agencies to ensure the Projects are eligible for State and Federal funding.
