An analysis of the factors contained in the project package, as well as the factors contained in Section VI.C. of Implementing Order 3-22 indicates that a 13.42% Small Business Enterprise – Construction (SBE-Con) Subcontractor Goal is appropriate for this contract in the following trade: Site Preparation Contractors (Site work).

An attempt was made to make this project a Set-Aside and a Verification of Availability to Bid letter was sent to SBE/Cons certified firms in NAICS codes 236210 (Industrial Building Construction) and 236220 (Commercial and Institutional Building Construction); however, no firms responded as being able to meet the contract's requirements.
