Reasons for Recommendation

An analysis of the factors contained in Section VI C of Implementing Order 3-22 indicate that a 21.94% SBE-Construction subcontractor goal is appropriate in the trades as follows: Highway, Street, and Bridge Construction (pavement marking & signage and concrete: sidewalk and curb and gutter) and Electrical Contractors and Other Wiring Installation Contractors (lighting).

An analysis of the factors contained in section VIII B of Implementing Order 3-41 & Ordinance 14-41 indicates a 1.26% Small Business Enterprise - GOODS & SERVICES Sub-Contractor Goal is also appropriate for this contract.


Reasons for Recommendation
<p>An analysis of the factors contained in Section V C of Implementing Order 3-32, as well as the responses of certified Small Business Enterprise - Architectural & Engineering (SBE-A&E) firms to the Verification of Availability to Propose process indicates that a 12.78% SBE-A&E Subconsultant Goal is appropriate for this contract.
