**Description of Project/Bid:** The Miami-Dade County Department of Transportation and Public Works needs to establish a non-exclusive Professional Services Agreement (PSA), to provide professional engineering design services and preparation of complete construction plans to include master planning and public involvement for widening the existing SW 157 Avenue roadway from 2 to 4 lanes from SW 42 Street to SW 26 Street. The project includes new raised landscape median, bike lanes, sidewalks, curb & gutters, storm drainage system, pavement markings and signage, intersection and signalization improvements, roadway lighting, environmental permitting, and construction administration services. The prime consultant should have a minimum of eight (8) years in business and demonstrate experience with at least 2 previously designed

 An analysis of the factors contained in the project package, as well as the factors contained in Section V. B. 2. C. of Implementing Order 3-32 indicates that a 20.00% SBE/AE Sub-Consultant Goal is appropriate for this contract in Technical Categories (TCs) 03.04 (Traffic Engineering Studies) – 3.00%, 03.05 (Traffic Counts) – 1.00%, 03.09 (Signing, Pavement Marking, and Channelization) – 5.00%, 03.11 (Signalization) – 6.00% and 09.02 (Geotechnical and Materials Engineering Services) -5.00%  
 An attempt was made to make this project a Set-Aside, however the certified firms that responded to the Verification of availability process did not meet the project's requirements.
