Description of Project/Bid:

DTPW has the need to establish two (2) non-exclusive Professional Services Agreements (PSA) to provide General Engineering Services for Permitting, Plan Reviews and Maintenance of Traffic

(MOT) Reviews.

The Engineering firm(s) will provide the department services related to Plan Review and will be responsible for examination and approval of the 5G telecommunications plans submitted for construction including but not limited to the review of permit package for new poles, antennas, appurtenance and fiber optic underground installation. In addition, the Engineer will be responsible for reviewing county maps, and must be familiar with county codes and ordinance. This staff will be housed at county offices and report to the appropriate supervisory staff as designated by the department.

The Reviewer will also review progress reports with supervisors concerning the progress of the 5G telecommunications program and shall attend progress meeting to prioritize sites for the different telecom providers.
