Description of Project/Bid: DTPW has a need to establish a Professional Services Agreement (PSA) to provide CEI services for contract administration, inspection, and materials sampling and testing in support of the Project. The Project will construct direct ramps to and from a proposed elevated Bus Rapid Transit (BRT) platform at the Dadeland South Metrorail Station platform level to provide a seamless transfer between the Transitway BRT service and the Metrorail service. The Project will also include improvements/refurbishment to the existing station to enhance passenger amenities and experience.
