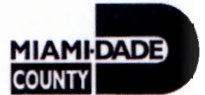


This is a request for Review Committee (RC) approval of the proposed Small Business Enterprise-Construction (SBE-CONST) goal in order to proceed with source removal, installation (drilling) and sampling of 21 soil borings & 8 monitoring wells, site restoration, disposal and reporting under the E14-RER-03 Professional Services Agreement for Project #001-D14/03-AECOM, Source Removal at the BLDG 119 site, located within the Miami Opa-locka Executive Airport, on behalf of the Miami-Dade Aviation Department

The subject project consists of the excavation of approximately 504 tons of contaminated soils, installation and sampling of 21 soil borings & 8 monitoring wells, site restoration, disposal, and reporting. This contract, a work order originating from the E14-RER-03 Professional Services Agreement, has been assigned to AECOM Technical Services, Inc. (AECOM) who will subcontract the source removal (excavation) and the installation of 21 soil borings & 8 monitoring wells.

**The Department of Regulatory and Economic Resource, Division of Environmental Resources Management (DERM), DERM staff has evaluated the project and recommends a 0.0% SBE subcontractor goal for the source removal/excavation scope (please see attached Analysis for SBE-CONST Goal Recommendation). The property is contaminated and therefore any excavation or removal work must be performed by personnel, including subcontractors, which are certified in accordance with OSHA standards in Hazardous Waste Operations and Emergency Response (HAZWOPER); a requirement that the selected excavation subcontractor meets. At this time, DERM is not aware of any OSHA HAZWOPER certified excavation companies on the SBE list. Additionally, DERM recommends a 0.0% SBE subcontractor goal for the soil boring and monitoring well installation (drilling) scope as DERM is not aware of any drilling companies on the SBE list. Therefore, DERM requests an exemption from the requirement to utilize SBE subcontractors for the source removal and soil boring & monitoring wells installation (drilling) scopes. Please advise DERM in the event of availability of SBE excavation and/or drilling companies.**




