This is a request for Review Committee (RC) approval of the proposed Small Business Enterprise Construction (SBE-CONST) goal in order to proceed with monitoring well installation (drilling), and sampling under the E14-RER-01 Professional Services Agreement for Project #012-D14/03-NOVA, Monitoring Well Installation and Sampling at the Modello Park site, located at 28450 SW 152 AVE, on behalf of the Parks, Recreation and Open Spaces Department.

The subject project consists of the installation (drilling) and sampling of three monitoring wells including a report. This contract, a work order originating from the E14-RER-01 Professional Services Agreement, has been assigned to Nova Consulting, Inc. who will subcontract the drilling work.

The Department of Regulatory and Economic Resources, Division of Environmental Resources Management (DERM), RER staff has evaluated the project and recommends a 0.0% SBE subcontractor goal for this project (please see attached Analysis for SBE-CONST Goal Recommendation).
