Description of Project/Bid:

This project is for the multi lane roadway construction from Port Boulevard to the connection of North Cruise Boulevard east of Cruise Terminal B. The scope of work consists of, but is not limited to: providing all labor, tools, materials, equipment, and incidentals necessary for the complete, functional, and satisfactory construction of the multi lane roadway, installation of new street lighting; new drainage system; relocation of existing utilities; new signing and pavement marking; new overhead guide sign; new CCTV camera pole / camera infrastructure, temporary maintenance of traffic, and any supportive ancillary tasks to the primary scope of

services, to successfully complete all phases of the project.

Reasons for Recommendation

SMALL BUSINESS ENTERPRISE - CONSTRUCTION (SBE-Con)

An analysis of the factors contained in Section VI. C. of Implementing Order 3-22 indicates that a 18.26% Small Business Enterprise Construction (SBE-Con) subcontractor goal is appropriate for the trades of Site Preparation Contractors (site work) at 2.50%; Highway, Street, and Bridge Construction (pavement marking & signage work) at 8.32% and Electrical Contractors and Other Wiring Installation Contractors (electrical work) at 7.49%.

SMALL BUSINESS ENTERPRISE - GOODS (SBE-Goods)

An analysis of the factors contained in section VIII. B. of Implementing Order 3-41& Ordinance 14-41 indicates that a 2.20% is appropriate for the SBE-Goods portion of this contract in the Commodity Codes; (25800) Electrical Cable And Wire, Not Electronic and (28000) Electrical Equipment And Supplies, Except Cable And Wire.

SBE-Goods subcontractor Goals can be met by 1st or 2nd Tier Subcontractor.

The project estimated cost amount is \$6,878,812.87 the total suggested SBE-Con goal is \$1,222,966.95 (18.26%) of the total project estimated cost, the total suggested SBE-Goods goal is \$147,354.00 (2.20%) of the total project estimated.

A 10% CWP Workforce Goal is appropriate for this contract.
