Description of Project/Bid: The Work of this Contract comprises the tasks necessary for the construction and installation of

(I) a new 8-inch diameter sanitary sewer collection pipeline, manhole structures and supporting appurtenances, demolition and/or removal of existing infrastructure (as necessary) and abandoning in place existing utilities; and (II) new communications raceways for fiber optic "backbone" (using directional boring methods). In addition, the Work of this Contract also comprises the tasks necessary for the construction of new paved access roadway(s) including all necessary pavement removal, excavation, embankment, pavement construction, signing and pavement marking, signs, tree removal, and temporary maintenance of traffic. The project shall

be located at the eastern corner of PortMiami.

Reasons for Recommendation

SMALL BUSINESS ENTERPRISE - CONSTRUCTION (SBE-Cons)

An analysis of the factors contained in Section VI. C. of Implementing Order 3-22 indicates that a 8.32% Small Business Enterprise – Construction (SBE-Con) subcontractor goal is appropriate for the trades of: Site Preparation Contractors (tree removal and relocation work) at 0.85% and (demolition work at 3.70%; Highway, Street, and Bridge Construction (Asphalt Paving and Pavement Marking and Signage work) at 2.90% and All Other Specialty Trade Contractors (fencing work) at 0.87%.

A 10% CWP Workforce Goal is goal is appropriate for this contract.
