Description of Project/Bid: The work includes but is not limited to the following: furnishing all supervision, materials, equipment, tools and performing all operations necessary for roadway improvements to NW 82nd Ave. from NW 7th St. to NW 12th St. The work consists of widening NW 82nd Avenue from two (2) to three (3) lanes from NW 7th Street to NW 10th Street and the construction of a new four (4) lane road under State Road (SR) 836 from NW 10th Street to NW 12th Street. The project will provide a connection to SR 836 that was left open as part of the SR 826/ SR 836 project.

Reasons for Recommendation

SMALL BUSINESS ENTERPRISE – CONSTRUCTION (SBE-Con)

An analysis of the factors contained in the project package, as well as the factors contained in Section VI.C. of Implementing Order 3-22 indicates that a 15.20% Small Business Enterprise – Construction (SBE-Con) Subcontractor Goal is appropriate for this contract in the following trades: Highway, Street and Bridge Construction (Concrete work) – 12.33% and Painting and Wall Covering Contractors (Signage and Paving Markings) – 2.87%.

An attempt was made to make this project a Set-Aside however, only one (1) firm responded to the Verification of Availability to Bid process as being able to meet the project’s requirements.

SMALL BUSINESS ENTERPRISE – SERVICES (SBE-Services)

An analysis of the factors contained in the project package, as well as the factors contained in Section VIII.B. of Implementing Order 3-41 & Ordinance 16-109 indicates a 0.26% Small Business Enterprise - Services (SBE-Services) Subcontractor Goal is appropriate for this contract in Commodity #98852 (Landscaping).




