<b>SMALL BUSINESS ENTERPRISE – CONSTRUCTION (SBE-Con)</b> An analysis of the factors contained in the project package, as well as the factors contained in Section VI.D. of Implementing Order 3-22 indicates that a SBE-Construction (SBE-Con) Trade Set Aside is appropriate for this contract in the following trades: -Highway, Street and Bridge Construction (Concrete work) -Painting and Wall Covering Contractors (Traffic Stripes and Markings: Painted and/or Thermoplastic). An attempt was made to make this project a Set-Aside and a Verification of Availability to Bid letter was sent to SBE-Con certified firms in NAICS codes 237310 (Highway, Street and Bridge Construction) and 237990 (Other Heavy and Civil Engineering Construction); however, only one (1) firm responded as being able to meet the contract's requirements.			
<b>SMALL BUSINESS ENTERPRISE - GOODS &amp; SERVICES (SBE-Goods and SBE-Services)</b> An analysis of the factors contained in the project package, as well as the factors contained in Implementing Order 3-41 indicates a No Measure is appropriate for the Goods and Service portion of this contract due to the lack of certified firms in the required commodities.
