Work includes but is not limited to, the following: Construction of Asphaltic Concrete Road base and surface; pavement removal; pavement milling; pavement markings; signage; drainage; sidewalks; concrete curb and gutter; and traffic calming devices. Incidental items required for areas such as street light, traffic signal installation, etc. may be added to this Contract.

<p>SMALL BUSINESS ENTERPRISE – CONSTRUCTION (SBE-Con) An analysis of the factors contained in the project package, as well as the factors contained in Section VI.D. of Implementing Order 3-22 indicates that a SBE-Construction (SBE-Con) Trade Set Aside is appropriate for this contract in the following trades: -Highway, Street and Bridge Construction (Concrete work) -Painting and Wall Covering Contractors (Traffic Stripes and Markings: Painted and/or Thermoplastic). An attempt was made to make this project a Set-Aside and a Verification of Availability to Bid letter was sent to SBE-Con certified firms in NAICS codes 237310 (Highway, Street and Bridge Construction) and 237990 (Other Heavy and Civil Engineering Construction); however, only one (1) firm responded as being able to meet the contract's requirements.</p>
