**Description of Project/Bid:** Work under this Contract includes furnishing of all supervision, labor, materials, tools, equipment and performing all operations required to construct the Work in accordance with the Contract Documents. Work includes but is not limited to the following: - Construction of the new bridge along SW 87 Ave over C-100 Canal. - Roadway connecting the existing SW 87 Ave to the North and South of the proposed bridge with one travel lane, one dedicated bike lane with physical raised separation, Curb & Gutter, and sidewalk in both directions (Northbound, and Southbound). - Roadway approach improvements to include, French Drainage, Storm Drainage System, Signing & Pavement Markings, Milling & Resurfacing guardrail installation, etc. Pedestrian lighting, landscaping, fencing.

<p>This is a resubmittal; the original submission of project 20220010 had a cost estimate of \$2,280,812.02, a SBE-Con goal of 22.01% and a SBE-Service goal of 0.26%. DTPW made design changes resulting to an increase of the cost estimate to \$3,054,403.01</p> <p><b>SMALL BUSINESS ENTERPRISE- CONSTRUCTION (SBE-Con)</b>            SBD reviewed this project pursuant to Implementing Order 3-22 for a SBE-Con measure. Project information analyzed included the project's scope of services, estimated project cost, minimum requirements/qualifications and funding source. These indicate a 3.60% SBE-Con subcontractor goal is appropriate for this contract in the following trades: Highway, Street and Bridge Construction (Concrete work) – 3.23% and Painting and Wall Covering Contractors (Pavement Marking and Signage) – 0.37%.
